- 1 A BILL FOR AN ACT relating to the Nebraska Rules of the Road; to amend 2 section 60-6,268, Revised Statutes Cumulative Supplement, 2014, 3 sections 60-6,265, 60-6,267, and 60-6,270, Revised Statutes 4 Supplement, 2015; to update federal references; to change and 5 eliminate provisions relating to the use and enforcement of occupant 6 protection systems; to repeal the original sections; and to outright 7 repeal section 60-6,271, Reissue Revised Statutes of Nebraska.
- 8 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 60-6,265, Revised Statutes Annual Supplement,

- 2 2015, is amended to read:
- 3 60-6,265 For purposes of sections 60-6,266 to 60-6,273:
- 4 (1) Occupant protection system means a system utilizing a lap belt,
- 5 a shoulder belt, or any combination of belts installed in a motor vehicle
- 6 which (a) restrains drivers and passengers and (b) conforms to Federal
- 7 Motor Vehicle Safety Standards, 49 C.F.R. 571.207, 571.208, 571.209, and
- 8 571.210, as such standards existed on January 1, 2016 2009, or to the
- 9 federal motor vehicle safety standards for passenger restraint systems
- 10 applicable for the motor vehicle's model year; and
- 11 (2) Three-point safety belt system means a system utilizing a
- 12 combination of a lap belt and a shoulder belt installed in a motor
- 13 vehicle which restrains drivers and passengers.
- 14 Sec. 2. Section 60-6,267, Revised Statutes Annual Supplement, 2015,
- 15 is amended to read:
- 16 60-6,267 (1) Any person in Nebraska who drives any motor vehicle
- 17 which has or is required to have an occupant protection system or a
- 18 three-point safety belt system shall ensure that all children up to six
- 19 years of age being transported by such vehicle use a child passenger
- 20 restraint system of a type which meets Federal Motor Vehicle Safety
- 21 Standard 213 as developed by the National Highway Traffic Safety
- 22 Administration, as such standard existed on January 1, 2016 2009, and
- 23 which is correctly installed in such vehicle.
- 24 (2) Any person in Nebraska who drives any motor vehicle which has or
- 25 is required to have an occupant protection system or a three-point safety
- 26 belt system shall ensure that all children six years of age and less than
- 27 eighteen years of age being transported by such vehicle use an occupant
- 28 protection system.
- 29 (3) Subsections (1) and (2) of this section apply to autocycles and
- 30 to every motor vehicle which is equipped with an occupant protection
- 31 system or is required to be equipped with restraint systems pursuant to

- 1 Federal Motor Vehicle Safety Standard 208, as such standard existed on
- 2 January 1, 2016 2009, except taxicabs, mopeds, motorcycles, and any motor
- 3 vehicle designated by the manufacturer as a 1963 year model or earlier
- 4 which is not equipped with an occupant protection system.
- 5 (4) Whenever any licensed physician determines, through accepted
- 6 medical procedures, that use of a child passenger restraint system by a
- 7 particular child would be harmful by reason of the child's weight,
- 8 physical condition, or other medical reason, the provisions of subsection
- 9 (1) or (2) of this section shall be waived. The driver of any vehicle
- 10 transporting such a child shall carry on his or her person or in the
- 11 vehicle a signed written statement of the physician identifying the child
- 12 and stating the grounds for such waiver.
- 13 (5) The drivers of authorized emergency vehicles shall not be
- 14 subject to the requirements of subsection (1) or (2) of this section when
- 15 operating such authorized emergency vehicles pursuant to their
- 16 employment.
- 17 (6) A driver of a motor vehicle shall not be subject to the
- 18 requirements of subsection (1) or (2) of this section if the motor
- 19 vehicle is being operated in a parade or exhibition and the parade or
- 20 exhibition is being conducted in accordance with applicable state law and
- 21 local ordinances and resolutions.
- 22 (7) The Department of Roads shall develop and implement an ongoing
- 23 statewide public information and education program regarding the use of
- 24 child passenger restraint systems and occupant protection systems and the
- 25 availability of distribution and discount programs for child passenger
- 26 restraint systems.
- 27 (8) All persons being transported by a motor vehicle operated by a
- 28 holder of a provisional operator's permit or a school permit shall use
- 29 such motor vehicle's occupant protection system or a three-point safety
- 30 belt system.
- 31 Sec. 3. Section 60-6,268, Revised Statutes Cumulative Supplement,

- 1 2014, is amended to read:
- 2 60-6,268 (1) A person violating any provision of subsection (1) or
- 3 (2) of section 60-6,267 shall be guilty of an infraction as defined in
- 4 section 29-431 and shall be fined twenty-five dollars for each violation.
- 5 The failure to provide a child restraint system for more than one child
- 6 in the same vehicle at the same time, as required in such subsection,
- 7 shall not be treated as a separate offense.
- 8 (2) Enforcement of subsection (2) or (8) of section 60-6,267 shall
- 9 be accomplished only as a secondary action when an operator of a motor
- 10 vehicle has been cited or charged with a violation or some other offense
- 11 unless the violation involves a person under the age of eighteen years
- 12 riding in or on any portion of the vehicle not designed or intended for
- 13 the use of passengers when the vehicle is in motion.
- 14 Sec. 4. Section 60-6,270, Revised Statutes Annual Supplement, 2015,
- is amended to read:
- 16 60-6,270 (1) Except as provided in subsection (2) or (3) of this
- 17 section, no driver shall operate a motor vehicle upon a highway or street
- 18 in this state unless the driver and each front-seat occupant in the motor
- 19 vehicle are wearing occupant protection systems and all occupant
- 20 protection systems worn are properly adjusted and fastened.
- 21 (2) Except as otherwise provided in subsection (3) of this section,
- 22 no driver shall operate an autocycle upon a highway or street of this
- 23 state unless the driver is wearing a three-point safety belt system and
- 24 it is properly adjusted and fastened.
- 25 (3) The following persons shall not be required to wear an occupant
- 26 protection system or a three-point safety belt system:
- 27 (a) A person who possesses written verification from a physician
- 28 that the person is unable to wear an occupant protection system or a
- 29 three-point safety belt system for medical reasons;
- 30 (b) A rural letter carrier of the United States Postal Service while
- 31 performing his or her duties as a rural letter carrier between the first

- 1 and last delivery points; and
- 2 (c) A member of an emergency medical service while involved in
- 3 patient care.
- 4 (4) For purposes of this section, motor vehicle means a vehicle
- 5 required by section 60-6,266 to be equipped with an occupant protection
- 6 system or a three-point safety belt system.

- 8 Supplement, 2014, and sections 60-6,265, 60-6,267, and 60-6,270, Revised
- 9 Statutes Supplement, 2015, are repealed.
