- 1 A BILL FOR AN ACT relating to fees; to amend section 33-106.02, Reissue
- 2 Revised Statutes of Nebraska; to change disposition of docket fees
- 3 as prescribed; to repeal the original section; and to declare an
- 4 emergency.
- 5 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 33-106.02, Reissue Revised Statutes of Nebraska,

- 2 is amended to read:
- 3 33-106.02 (1) The clerk of the district court of each county shall
- 4 not retain for his or her own use any fees, revenue, perquisites, or
- 5 receipts, fixed, enumerated, or provided in this or any other section of
- 6 the statutes of the State of Nebraska or any fees authorized by federal
- 7 law to be collected or retained by a county official. The clerk shall on
- 8 or before the fifteenth day of each month make a report to the county
- 9 board, under oath, showing the different items of such fees, revenue,
- 10 perquisites, or receipts received, from whom, at what time, and for what
- 11 service, and the total amount received by such officer since the last
- 12 report, and also the amount received for the current year.
- 13 (2) The clerk shall account for and pay any fees, revenue,
- 14 perquisites, or receipts not later than the fifteenth day of the month
- 15 following the calendar month in which such fees, revenue, perquisites, or
- 16 receipts were received in the following manner:
- 17 (a) Of the forty-two-dollar docket fee imposed pursuant to section
- 18 33-106, through June 30, 2016, five dollars shall be remitted to the
- 19 State Treasurer for credit to the General Fund and two dollars shall be
- 20 remitted to the State Treasurer for credit to the Nebraska Retirement
- 21 Fund for Judges, beginning July 1, 2016, through June 30, 2017, three
- 22 dollars shall be remitted to the State Treasurer for credit to the
- 23 General Fund and four dollars shall be remitted to the State Treasurer
- 24 for credit to the Nebraska Retirement Fund for Judges, and beginning July
- 25 1, 2017, one dollar shall be remitted to the State Treasurer for credit
- 26 to the General Fund and six dollars shall be remitted to the State
- 27 Treasurer for credit to the Nebraska Retirement Fund for Judges;
- (b) Of the twenty-seven-dollar docket fee imposed for appeal of a
- 29 criminal case to the district court pursuant to section 33-106, two
- 30 dollars shall be remitted to the State Treasurer for credit to the
- 31 Nebraska Retirement Fund for Judges; and

1 (c) The remaining fees, revenue, perquisites, or receipts shall be

- 2 credited to the general fund of the county.
- 3 Sec. 2. Original section 33-106.02, Reissue Revised Statutes of
- 4 Nebraska, is repealed.
- 5 Sec. 3. Since an emergency exists, this act takes effect when
- 6 passed and approved according to law.
