- 1 A BILL FOR AN ACT relating to claims against the state; to appropriate
- 2 funds for the payment of certain claims; to provide for payment of
- 3 the claims; to authorize agencies to write off certain claims as
- 4 prescribed; and to declare an emergency.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. The following sums of money, or so much thereof as may
- 2 <u>be required</u>, are hereby appropriated from the General Fund or from other
- 3 funds as indicated in the state treasury, not otherwise appropriated, for
- 4 the payment of tort claims which have been settled by the State Claims
- 5 Board and approved by the district court, which have been settled by the
- 6 Attorney General in the district court, or in which court judgments have
- 7 been entered and which require the approval of the Legislature for
- 8 <u>payment</u>.
- 9 \$84,675.14 for Tort Claim Number 2015-14421, against the State of
- 10 Nebraska, pay to Cottingham and Butler Claims Services, 800 Main Street,
- 11 <u>Dubuque, IA 52001-6822, out of the Roads Operations Cash Fund.</u>
- 12 <u>\$243,098.57 for Tort Claim Number 2016-15417, against the State of</u>
- 13 Nebraska, pay to Nebraska Appleseed Center for Law, 941 0 Street, Suite
- 14 920, Lincoln, NE 68508-3608, out of the General Fund.
- 15 <u>\$115,336.81</u> for Tort Claim Number 2016-15418, against the State of
- 16 Nebraska, pay to Husch Blackwell, LLP, 13330 California Street, Suite
- 17 200, Omaha, NE 68154-5241, out of the General Fund.

- 26 Sec. 2. The Director of Administrative Services is hereby
- 27 authorized and directed to draw his or her warrants upon the funds in the
- 28 state treasury enumerated in this act, in favor of the several
- 29 beneficiaries named in this act for the amount set opposite their
- 30 respective names, upon the presentation of proper vouchers therefor. The
- 31 several amounts appropriated in this act shall be in full payment of any

- 1 and all claims, rights, causes of action, damages, and demands of every
- 2 character and kind owing by or against the State of Nebraska, its
- 3 officers, agents, and employees, and their successors and assigns with
- 4 respect to each of the beneficiaries respectively in whose favor the
- 5 appropriations are made. The director shall not deliver any warrant for
- 6 any items appropriated in this act until a receipt and release in full,
- 7 releasing the State of Nebraska, its officers, employees, and agents, and
- 8 their successors and assigns, has been filed by each of the beneficiaries
- 9 respectively. Upon presentation of the warrants, the State Treasurer is
- 10 hereby directed to pay the same out of money in the General Fund or out
- 11 of money in other funds indicated in this act not otherwise appropriated.
