Introducer's Statement of Intent

The following constitutes the reasons for this bill and the purposes which are sought to be accomplished thereby:

• Amends Nebraska Revised Statutes 37-1282 and 60-164 to remove the requirement to issue a paper title for certain changes to motorboat and vehicle titles if the certificate is electronic.

• Amends Nebraska Revised Statute 60-144 to allow for dealer automated services for titles.

• Amends Nebraska Revised Statute 60-385 to allow for dealer automated services for registrations.

• Amends Nebraska Revised Statutes 69-168.02; 60-3,104; 60-3,104.01;60-3,118; 60-3,120; 60-3,121; 60-3,122; 60-3,122.02; 60-3,122.04; 60-3,123; 60-3,124; 60-3,125; 60-3,126; 60-3,128; and 60-3,224 to clean up the definition of trailer and cabin trailer.

• Amends Nebraska Revised Statutes 60-308 to eliminate charter buses from the exemption to the definition of apportioned vehicles.

• Amends Nebraska Revised Statute 60-396 to change refund provisions for disabled motor vehicles.

• Amends Nebraska Revised Statute 60-3,104.02 to reduce from 500 to 250 the number of prepaid orders required for specialty organizational plates.

• Amends Nebraska Revised Statute 60-3,113.05 to remove obsolete language regarding handicap plates.

• Amends Nebraska Revised Statute 60-3,198 to delete outdated language for issuing refunds for registrations for apportioned vehicles which become disabled; and inserts language that unladen weight registrations be issued for vehicles with a Nebraska based fleet.

• Amends Nebraska Revised Statute 60-3,202 to correct an error when the statute was recodified in 2005 where the word apportioned was put in place of the word vehicle.

• Amends Nebraska Revised Statute 60-3,222 to give the DMV the same authorization counties now have to cancel a registration for a bad check, etc.

• Amends Nebraska Revised Statutes 60-4,124; 60-4,120.01; and 60-4,130.04 to allow for the submission of electronic reports from Driver Training Schools.

• New Language is added in Section 37; and Nebraska Revised Statutes 60-4,149 and 60-4,150 are amended to provide for online renewals and replacements of some Commercial Driver Licenses.

• Amends Nebraska Revised Statute 75-385 to remove obsolete language about the Director appointing the Motor Carrier Administrator.

• Amends references to the Health Advisory Board in Nebraska Revised Statutes 60-4,105; 60-4,118; and 60-4,146; and outright repeals Nebraska Revised Statutes 60-4,118.01; 60-4,118.02; 60-4,118.03; and 60-4,118.04 dealing with the Health Advisory Board.
