Dear Mr. O'Donnell,

According to Nebraska State Statues, Chapter 82 Section 333, the Nebraska Arts Council shall provide the Clerk of the Legislature and Director of Administrative Services annually the Nebraska Arts and Humanities Cash Fund report. Please review the following information for the period of July 1, 2017 to June 30, 2018.

- 1) Enclosed is an overview of the Nebraska Cultural Endowment, which raises the matching funds for the Cultural Preservation Endowment Fund. The Nebraska Arts and Humanities Cash Fund (26920) consists of all funds credited from the Cultural Preservation Endowment Fund.
- 2) The funds credited to the Nebraska Arts and Humanities Cash Fund (26920) totalled \$859,560.



On behalf of the hundreds-of-thousands of Nebraska children, veterans, young professionals, seniors, cultural professionals, and residents who have benefitted from the programs and grants of Nebraska Arts Council and Humanities Nebraska in 2017, we would like to thank our donor investors and stakeholders for their transformational support of the Nebraska Cultural Endowment. # THE ARTS AND HUMANITIES MEAN BUSINESS

The Nebraska Cultural Endowment firmly believes that a strong cultural sector is good for business, especially in smaller communities throughout Greater Nebraska. A great example of this synergy between the arts and humanities and business and commerce is the Buffalo Commons Storytelling and Music Festival in McCook, Nebraska.

The two-day festival generates an estimated \$69,791 in spending on things like accommodations, retail sales, food service and transportation. \$45,416 of that originates from outside the county, creating a significant influx of commerce into the McCook community in just 48 hours. This economic boost is expected to grow by 20% in 2018.

It is a unique way to bring our history and our future together. It's a great economic boost for the weekend, allowing our great community to prosper.

Thanks to this cultural resource, which is supported by both the Nebraska Arts Council and Humanities Nebraska, it is estimated that \$5,251 was generated in tax receipts for state and local governments in 2017. The budget and audience has steadily increased over the last three years, thanks to investment by NAC, HN and other sources.

By creating events for people to attend, we are creating a reason for visitors to come to McCook and to spend money. It is vitally important that we have 'new' money come in and not just circulate the dollars that originate in the community.




