***Status Definitions**

OR (Orientation) – Initial placement of individuals upon arrival to NDCS. Used to evaluate risk / needs of individual in order to determine appropriate custody placement and programming needs. Generally completed within 30 days.

GP (General Population) – Housing status of individuals that are not restricted from normal daily activities or movement. Includes individuals that have requested protective custody.

IS (Immediate Segregation) - Short-term restrictive housing assignment in response to behavior that creates a risk to the inmate, others, or the security of the institution. Used to maintain safety and security while investigations are completed, and/or appropriate housing is identified. Individuals are transitioned back to general population or placed on LTRH within 30 days. During this time, individuals are seen by medical and a mental health therapist regularly. They have access to recreation / exercise opportunities, are permitted to shower, complete social and legal phone calls and have visitation with their family or attorney.

LTRH (Long Term Restrictive Housing) - Risk management intervention for individuals whose behavior continues to pose a risk to the safety of themselves or others. Individuals develop a behavior plan and participate in evidence-based risk-reducing cognitive behavioral programming to facilitate the transition from restrictive housing back to general population. During this time, individuals are seen by medical and a mental health therapist regularly. They have access to recreation/exercise opportunities, are permitted to shower, complete social and legal phone calls and have visitation with their family or attorney. Individuals receive additional incentives for participation in their behavior plan.
