Notice is hereby given that the Secretary of State will hold a rule making hearing on September 11, 2018 at 10:30 a.m. in the 2<sup>nd</sup> Floor Conference Room of the Center on N Building, 1221 N Street, Lincoln, NE. The purpose of this hearing is to receive public testimony on amendments to Nebraska Administrative Code, Title 438, Central Filing Information Regarding Agricultural Products. The purpose of the proposed amendments is to change the method and timing of distribution of the Master Lien List consistent with LB 1035 (2016).

Copies of the proposed rule and the description, including an estimated quantification, of the fiscal impact on state agencies, political subdivisions, and persons being regulated are available for public examination at the Secretary of State's Office, Suite 2300, State Capitol Building, Lincoln, Nebraska 68509, telephone (402) 471-4070.

### Provide an Estimated Cost & Description of Impact:

The amended regulations along with changes to the law via LB 1035 (2016) allow the Master Lien List to be published online on a monthly basis. Currently, the report is distributed via paper, microfiche, and CD on a quarterly basis. The costs for the online programming of the Master Lien List were included in the RFP for the new Business Services software system and are not reflected in this fiscal note. The ability to publish the list online eliminates certified mail costs and existing vendor costs associated with producing the CDs, microfiche and paper lists.

#### State Agency:

The Secretary of State estimates savings of \$27,780 related to mailing costs and vendor costs associated with providing the master lien list via CD, paper, and microfiche.

#### **Political Subdivision:**

No fiscal impact.

#### Regulated Public:

The amended regulations propose a flat fee of \$100 to access the Master Lien List online. Previous prices for the CDs were \$160, \$200 for paper, and \$25 for microfiche. Most subscribers of the list are currently paying \$160 per CD and will see a \$60 annual savings to access the list online.

Pursuant to Neb. Rev. Stat. § 84-907.09, enclosed and below are the following items relating to the proposed amended regulations, Title 438, Central Filing Information Regarding Agricultural Products:

- 1. A copy of the proposed rule and fiscal impact statement.
- 2. The purpose of the proposed amendments is to change the method and timing of distribution of the Master Lien List consistent with LB 1035 (2016). The regulation impacts individuals and entities that subscribe to the Master Lien List related to farm products or use the central filing system for security interests relating to farm products pursuant to section 1324 of the Food Security Act of 1985.
- 3. The regulation is necessary to carry out functions of the Secretary of State as specified in Neb. Rev. Stat. §\$52-1301 through 52-3122 and §\$52-1601 through 52-1605 and is authorized by Neb. Rev. Stat. §52-1312 and §52-1605.
- 4. The proposed rule is consistent with the legislative intent of Neb. Rev. Stat. §52-1312 and §52-1605.
- 5. The proposed rule is not a result of a state or federal mandate.
- 6. The Secretary of State will solicit public comment on the proposed rule or regulation before the public hearing.
- 7. The Secretary of State did not utilize the negotiated rulemaking process as provided for in the Negotiated Rulemaking Act.

#### **CHAPTER 1 – DEFINITIONS**

- 001. In addition to the agricultural commodities and species of livestock set forth in section 8 of LB 1, Legislature of Nebraska, Eighty Ninth Legislature, Third Special Session, there is hereby added to the specified list of farm products: Bees.
  - 001.01 In order to obtain U.S.D.A. certification and comply with federal law, section 1324 of the Food Security Act of 1985, Public Law 99-1987, the following products are deleted from the definition of farm products:

#### 001.01A Legumes, Fur-Bearing Animals

001.02 In addition to the agricultural commodities and species of livestock set forth in section 8 of LB 1, Legislature of Nebraska, Eighty-Ninth Legislature, Third Special Session, there is hereby added to the specified list of Farm Products: millet and safflower. These commodities are to become part of the Central Filing System effective at the beginning of the first calendar quarter occurring 30 days after approval of such addition is received from the U.S.D.A.

- O02 Effective Financing Statement(s) means a statement or statements as defined in Neb. Rev. Stat. §52-1307 (R.S.SUPP., 2017)
- 003 Filing Office and Filing Officer mean the Nebraska Secretary of State.
- Master Lien List means the compiled master list of all information from Effective

  Financing Statements filed with the Filing Office and lien information relative to liens

  created under Chapter 52, articles 2, 5, 7, 9, 11, 12, and 14, and Chapter 54, article 2 of

  the Nebraska Revised Statutes received by the Filing Office pursuant to subsection (a) of
  section 9-530 of the Uniform Commercial Code.

## CHAPTER 2 – TIME OF EFFECTIVENESS OF EFS EFFECTIVE FINANCING STATEMENT AND RELATED DOCUMENTS.

O01. An Effective Financing Statement, and amendment, continuation, or termination thereof, is not a part of the Master Lien List of the Central Filing System-created pursuant to LB 1, Legislature of Nebraska, Eighty Ninth Legislature, Third Special Session, and not effective as notice to any registrant or person inquiring until the document has been properly filed with the fFiling oOfficer, such fFiling oOfficer has caused the information therefrom to be entered into the computer system, and the information is contained in the Master Lien List of the Central Filing System.

#### CHAPTER 3 WORKING DAY DEFINED.

001. Working day shall mean for the office involved a day when the office is open for the transaction of that office's normal business. A working day shall not include a weekend day or a holiday.

CHAPTER 43 – DATE AFTER WHICH AN EFFECTIVE FINANCING STATEMENT FILING WILL NOT APPEAR ON QUARTERLY MONTHLY LISTINGS.

001. In order for the information contained in an Effective Financing Statement or an amendment or continuation thereof to appear on the next quarterly lists distributed Master Lien List published by the Filing Office, pursuant to section 12(6) of LB 1, Legislature of Nebraska, Eighty Ninth Legislature, Third Special Session, such Effective Financing Statement amendment or continuation shall be filed on or before the last working day of the month, preceding the date on which lists will be mailed pursuant to Chapter 5.

CHAPTER 54 – DATE FOR QUARTERLY DISTRIBUTION MONTHLY PUBLICATION OF LISTS RELATING TO EFFECTIVE FINANCING STATEMENTS.

- 001. The Master Lien List lists required to be distributed on a quarterly basis pursuant to section 12(6) of LB 1, Legislature of Nebraska, Eighty Ninth Legislature, Third Special Session, will, after the first distribution, shall be published on a monthly basis on the Filing Office's website mailed from the Secretary of State's Office by the Fifth working day of the month. January, April, July and October.
  - 001.01 <u>Lists Master Lien Lists for any quarter month shallwill</u> remain effective until the next quarterly\_lists are received\_monthly Master Lien List is published.

### CHAPTER 65 – DATES OF WHICH BUYERS MUST REGISTER

- 001. In order to receive the next quarterly list or lists pursuant to Section 12 of LB 1,
  Legislature of Nebraska, Eighty Ninth Legislature, Third Special Session, a
  registrant's properly completed registration form accompanied by the correct
  registration fee and list fees must be received by the Secretary of State on or before
  the following dates:
- 001. Registration shall be on an annual basis. The fee for annual registration shall be thirty dollars. In addition to the annual registration fee, the fee for receiving the Master Lien List shall be one hundred dollars per user. The annual registration fee and Master Lien List fee shall not be prorated regardless of the date of registration.
- O02. In order to receive the next monthly Master Lien List, a registrant's properly completed registration form accompanied by the correct registration fee and Master Lien List fee must be received by the Secretary of State on or before 10 working days prior to the end of the month.

#### 001.01 Dates:

- 001.01A To receive statewide lists—the last working day of the month preceding the month in which lists will be mailed pursuant to Chapter 5.
- 001.01B To receive a special list (a list limited to fewer than all counties or less than all crop years) five working days prior to the end of the month preceding the month in which lists will be mailed pursuant to Chapter 5.

## CENTRAL FILING INFORMATION REGARDING AGRICULTURAL PRODUCTS

O02. Any Registrant's whose properly completed registration form accompanied by the correct registration and list fees is received before the 15<sup>th</sup> day of the month preceding the month in which lists will be mailed pursuant to Chapter 5 shall receive a list or lists for the product, years, and counties covered by the registration. Such list or lists shall reflect for statewide lists the information on the Master List at the beginning of the calendar quarter during which the registration was received and for special lists the information on the Master List as of the date the list or lists are prepared by the Secretary of State. Such list or lists will be mailed within 15 days after receipt of the Registration by the Secretary of State.

# CENTRAL FILING INFORMATION REGARDING AGRICULTURAL PRODUCTS

### CHAPTER 76 – EFFECTIVE DATE OF REGISTRATIONS.

O01. A registration shall be effective the date that the first Master Lien Listlist for which the registration is effective is received. Date of receipt is the date actually received or the first date upon which the Filing Office made the most current Master Lien List available electronically. delivery is attempted by the carrier, whichever is earlier. In all cases, date of receipt shall be presumed to be ten days after mailing.
