- LB 368 (*Lowe*) Change helmet provisions, change passenger age limits, and require eye protection for operators of motorcycles and mopeds
- LB 271 (*Hilgers*) Authorize the Department of Roads to assume certain responsibilities under federal environmental laws and provide for limited waiver of the state's sovereign immunity

- LB 315 (*Murante*) Change provisions relating to the sale of real property by a city of the second class or village

- LB 317 (*Hughes*) Provide for a relevy or reassessment of a special assessment for cities of the second class or villages as prescribed
- LB 17 (*Craighead*) Change and eliminate provisions of the Real Property Appraiser Act and the Nebraska Appraisal Management Company Registration Act
- LB 35 (*Harr*) Change provisions relating to the Nebraska Model Business Corporation Act
- LB 138 (*Lindstrom*) Provide for transfer of business interests under uniform transfer-on-death security registration
- LB 142 (*Williams*) Redefine effective financing statement and change provisions relating to the master lien list with respect to farm product security interests
- LB 182 (*Hughes*) Change powers and duties of the Department of Environmental Quality under the Drinking Water State Revolving Fund Act
- LB 6 (*Krist*) Provide for release of a summarized report by the office of Inspector General of Nebraska Child Welfare
- LB 207 (*Krist*) Change provisions relating to powers and duties of the Office of Inspector General of Nebraska Child Welfare
