Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill, as amended by AM1971, would provide a procedure to set aside convictions and adjudications of victims of sex trafficking and to expunge related records.

The Supreme Court states that this bill, as amended by AM1971, is estimated to have a minimal impact on expenditures, court fee revenue and court workload. It is assumed the volume of petitions to set aside and motions to seal will not be significant.

The Board of Parole, Attorney General, and Crime Commission estimate no fiscal impact from this bill, as amended by AM1971.

The bill was also amended by AM2361, which contained the following bills: LB678 with Judiciary AM1928, LB855 with Judiciary AM1780, and LB897 with Judiciary AM2342.

LB678 with Judiciary AM1928 would provide a judicial petition and review process for the sealing of court records relating to criminal prosecutions in which charges were dismissed. The committee amendment strikes a provision relating to a corrections overcrowding emergency that was included in the introduced copy of LB678. Striking this provision removes the fiscal impact estimated by the Nebraska Department of Correctional Services (NDCS).

LB855 with Judiciary AM1780 would allow any person who has received a pardon to file a motion with the sentencing court for an order to seal the criminal history record information and any cases related to such charges or conviction.

LB897 with Judiciary AM2342 makes exemptions in the statute that requires medical providers to report injuries that are the result of violence or the commission of a criminal offense to law enforcement. If a victim appears to have been the victim of a sexual assault or attempted sexual assault, they must give written consent before a medical provider may contact law enforcement. It also allows a victim to report anonymously while still receiving treatment and obtaining a sexual assault evidence collection kit. It provides for referral to an advocate, unless such referral is declined by the victim. Mandatory reporting is still required if the victim is suffering from a serious bodily injury or a bodily injury where a deadly weapon was used to inflict such injury. On or before July 1, 2019, the Attorney General shall develop and distribute a statewide model anonymous reporting protocol for use by health care providers. Once developed, the statewide model anonymous reporting protocol shall be maintained by the Nebraska Commission on Law Enforcement and Criminal Justice, commonly known as the Crime Commission.

Certain provisions of AM2361 apply retroactively.

The Supreme Court states that the fiscal impact on revenue, expenditures, and court workload from LB1132, as amended by AM2361, is not estimated to be significant. The Court further states that no additional resources are needed at this time.

The Department of Health and Human Services (HHS) has contacted the Legislative Fiscal Office and stated that there is no fiscal impact from AM2361.

The Board of Parole and Crime Commission estimate no fiscal impact from this bill, as amended by AM2361.
