LB 472 changes provisions relating to signs and advertising on highways. The Dept. of Transportation at its discretion may require a permit for advertising signs, displays or devices along the Highway Beautification Control System. This bill changes the Departments authorization to charge a fee to no fees being charged for such permits.
