Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would provide procedure to withhold from the public law enforcement officers' residential addresses in county records. This act becomes operative on January 1, 2018. As amended, the bill eliminates the fee provisions.

It appears that this bill will not have any significant fiscal impact to the state.

Lancaster County estimates a one-time expenditure impact of \$10,000 in FY18. The expenditure impact appears to be due to computer software modifications.

They further state that if this bill intends to require some blocking or redacting of addresses that may be included within documents recorded in the Register of Deeds Office, the fiscal costs will increase substantially, especially if previously recorded documents are to be impacted. See the county response attached for additional details not included in this fiscal note.
