It would be up to the department whether to agree to the new terms or conditions.

LB 78 is authorizing legislation and as such will not have a direct fiscal impact. No fiscal impact will occur until such time that a political subdivision petitions the department to renegotiate the agreement and the department agrees to changes which have a fiscal impact.
