1 A BILL FOR AN ACT relating to appropriations; to amend section 219,
2 Legislative Bill 327, One Hundred Fifth Legislature, First Session,
3 2017; to reduce appropriations and associated earmarks; to
4 appropriate funds to aid in carrying out the provisions of
5 Legislative Bill 268, One Hundred Fifth Legislature, First Session,
6 2017; to change an appropriation as prescribed; to provide an
7 operative date; to repeal the original section; and to declare an
8 emergency.
9 Be it enacted by the people of the State of Nebraska,

1 Section 1. There is hereby appropriated (1) \$152,140 from the
2 General Fund, \$152,140 from federal funds, and \$132,818 from the Health
3 and Human Services Cash Fund for FY2017-18 and (2) \$187,354 from the
4 General Fund, \$187,354 from federal funds, and \$152,425 from the Health
5 and Human Services Cash Fund for FY2018-19 to the Department of Health
6 and Human Services, for Program 33, to aid in carrying out the provisions
7 of Legislative Bill 268, One Hundred Fifth Legislature, First Session,
8 2017.

9 Total expenditures for permanent and temporary salaries and per
10 diems from funds appropriated in this section shall not exceed \$267,942
11 for FY2017-18 or \$357,257 for FY2018-19.

12 Sec. 2. The General Fund appropriation for FY2018-19 to the
13 Department of Health and Human Services, for Program 348, is hereby
14 reduced by \$384,000. The federal fund estimated appropriation for
15 FY2018-19 to the Department of Health and Human Services, for Program
16 348, is hereby reduced by \$416,000. For FY2018-19 the state aid General
17 Fund earmark in the Department of Health and Human Services, for Program
18 348, is hereby reduced by \$384,000 and the federal fund state aid earmark
19 is also hereby reduced by \$416,000.

20 Sec. 3. Section 219, Legislative Bill 327, One Hundred Fifth
21 Legislature, First Session, 2017, is amended to read:
