- and Human Services, for Program 33, to aid in carrying out the provisions 6

- 9 Total expenditures for permanent and temporary salaries and per
- 10 diems from funds appropriated in this section shall not exceed \$267,942
- for FY2017-18 or \$357,257 for FY2018-19. 11
