- 1 A BILL FOR AN ACT relating to the Abstracters Act; to amend sections
- 2 76-542 and 76-546, Reissue Revised Statutes of Nebraska; to
- 3 eliminate an experience requirement for registered abstracters and
- 4 temporary certificates of registration; to harmonize provisions; and
- 5 to repeal the original sections.
- 6 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 76-542, Reissue Revised Statutes of Nebraska, is

- 2 amended to read:
- 3 76-542 Any individual desiring to become a registered abstracter
- 4 shall file an application for registration with the board. Such applicant
- 5 shall have reached the age of majority, and shall not have been convicted
- 6 of a felony, and shall have at least one year of verified land title-
- 7 related experience satisfactory to the board. Each applicant for
- 8 registration shall take the written examination prescribed by section
- 9 76-543.
- 10 Such application shall be in a form prepared by the board and shall
- 11 contain the applicant's social security number and such information as
- 12 may be necessary to assist the board in determining the qualification of
- 13 the applicant for registration. Each such application shall be
- 14 accompanied by (1) an application fee of not less than twenty-five
- 15 dollars or more than one hundred dollars and (2) an examination fee of
- 16 not less than twenty-five dollars or more than one hundred dollars. The
- 17 board shall establish such fees based on the administrative costs of the
- 18 board.
- 19 Upon receipt of such application the board shall notify the
- 20 applicant by mail whether the application has been accepted. If the
- 21 application has not been accepted, the examination fee shall be returned
- 22 to the applicant. If the application has been accepted, the applicant
- 23 shall be notified of the time and place of the next scheduled
- 24 examination.
- The board shall adopt and promulgate rules and regulations necessary
- 26 to establish the experience standards and administer the examination
- 27 required for registered abstracters.
- 28 Sec. 2. Section 76-546, Reissue Revised Statutes of Nebraska, is
- 29 amended to read:
- 30 76-546 The board may, upon application to it by (1) any individual
- 31 succeeding to the ownership of any abstract business by any means other

- 1 than by purchase or (2) any individual who, by reason of the incapacity of any registered abstracter owner of any abstract business, is required 2 to assume the operation of such business, grant to such individual, 3 4 without examination, a temporary certificate of registration. application shall include the applicant's social security number. Such 5 temporary certificate shall be issued only after the applicant provides 6 7 proof of land title-related experience sufficient to meet the standards 8 established by the board. The fee for such temporary certificate of 9 registration shall be not less than twenty-five or more than one hundred dollars. The board shall establish such fee based on the administrative 10 costs of the board. Such certificate shall expire six months after its 11 date or upon the expiration of sixty days after the next regularly 12 13 scheduled examination which could be taken by the applicant under the rules and regulations of the board, whichever period is the longer. The 14 board shall notify such applicant by mail of the time and place of such 15 16 examination.
