1 Section 1. Section 13-508, Revised Statutes Cumulative Supplement,
2 2016, is amended to read:

3 13-508 (1) After publication and hearing thereon and within the time
4 prescribed by law, each governing body, ~~except as provided in subsection~~
5 ~~(3) of this section,~~ shall file with and certify to the levying board or
6 boards on or before September 20 of each year or September 20 of the
7 final year of a biennial period and file with the auditor a copy of the
8 adopted budget statement which complies with sections 13-518 to 13-522 or
9 79-1023 to 79-1030, together with the amount of the tax required to fund
10 the adopted budget, setting out separately (a) the amount to be levied
11 for the payment of principal or interest on bonds issued by the governing
12 body and (b) the amount to be levied for all other purposes. Proof of
13 publication shall be attached to the statements. For fiscal years prior
14 to fiscal year 2017-18, learning communities shall also file a copy of
15 such adopted budget statement with member school districts on or before
16 September 1 of each year. The governing body, in certifying the amount
17 required, may make allowance for delinquent taxes not exceeding five
18 percent of the amount required plus the actual percentage of delinquent
19 taxes for the preceding tax year or biennial period and for the amount of
20 estimated tax loss from any pending or anticipated litigation which
21 involves taxation and in which tax collections have been or can be
22 withheld or escrowed by court order. For purposes of this section,
23 anticipated litigation shall be limited to the anticipation of an action
24 being filed by a taxpayer who or which filed a similar action for the
25 preceding year or biennial period which is still pending. Except for such
26 allowances, a governing body shall not certify an amount of tax more than
27 one percent greater or lesser than the amount determined under section
28 13-505.

29 (2) Each governing body shall use the certified taxable values as
30 provided by the county assessor pursuant to section 13-509 for the
31 current year in setting or certifying the levy. Each governing body may

1 designate one of its members to perform any duty or responsibility
2 required of such body by this section.

4 ~~certification required by subsection (1) of this section on or before~~
5 ~~August 1 of each year.~~

6 ~~(b) For fiscal years prior to fiscal year 2017-18, learning~~

9 Sec. 2. Section 32-570, Reissue Revised Statutes of Nebraska, is
10 amended to read:

11 32-570 (1) A vacancy in the membership of a school board shall occur
12 as set forth in section 32-560 or in the case of absences, unless excused
13 by a majority of the remaining members of the board, when a member is
14 absent from the district for a continuous period of sixty days at one
15 time or from more than two consecutive regular meetings of the board. The
16 resignation of a member or any other reason for a vacancy shall be made a
17 part of the minutes of the school board. The school board shall give
18 notice of the date the vacancy occurred, the office vacated, and the
19 length of the unexpired term (a) in writing to the election commissioner
20 or county clerk and (b) by a notice published in a newspaper of general
21 circulation in the school district.

22 ~~(2) A person appointed to fill a vacancy on the school board of a~~
23 ~~Class I school district by the remaining members of the board shall hold~~
24 ~~office until the beginning of the next school year. A board member of a~~
25 ~~Class I school district elected to fill a vacancy at a regular or special~~
26 ~~school district meeting shall serve for the remainder of the unexpired~~
27 ~~term or until a successor is elected and qualified.~~

28 (2) ~~(3)~~ Except as provided in subsection ~~(3)~~ ~~(4)~~ of this section, a
29 vacancy in the membership of a school board of a Class II, III, IV, V, or
30 VI school district resulting from any cause other than the expiration of
31 a term shall be filled by appointment of a qualified registered voter by

1 the remaining members of the board for the remainder of the unexpired
2 term. A registered voter appointed pursuant to this subsection shall meet
3 the same requirements as the member whose office is vacant.

4 (3) ~~(4)~~ Any vacancy in the membership of a school board of a school
5 district described in section 79-549 which does not nominate candidates
6 at a primary election and elect members at the following general election
7 shall be filled by appointment of a qualified registered voter by the
8 remaining members of the board for the remainder of the unexpired term.

9 (4) ~~(5)~~ If any school board fails to fill a vacancy on the board,
10 the vacancy may be filled by election at a special election or school
11 district meeting called for that purpose. Such election or meeting shall
12 be called in the same manner and subject to the same procedures as other
13 special elections or school district meetings.

14 (5) ~~(6)~~ If there are vacancies in the offices of one-half or more of
15 the members of a school board, the Secretary of State shall conduct a
16 special school district election to fill such vacancies.

17 Sec. 3. Section 32-606, Reissue Revised Statutes of Nebraska, is
18 amended to read:

19 32-606 (1) Any candidate may place his or her name on the primary
20 election ballot by filing a candidate filing form prescribed by the
21 Secretary of State as provided in section 32-607. If a candidate for an
22 elective office is an incumbent of any elective office, the filing period
23 for filing the candidate filing form shall be between December 1 and
24 February 15 prior to the date of the primary election, except for
25 candidates for election in 2013 to the board of education of a Class V
26 school district. No incumbent who resigns from elective office prior to
27 the expiration of his or her term shall file for any office after
28 February 15 of that election year. Incumbent and nonincumbent candidates
29 for election in 2013 to the board of education of a Class V school
30 district and all other candidates shall file for office between December
31 1 and March 1 prior to the date of the primary election. A candidate

1 filing form may be transmitted by facsimile for the offices listed in
2 subdivision (1) of section 32-607 if (a) the transmission is received in
3 the office of the filing officer by the filing deadline and (b) the
4 original filing form is mailed to the filing officer with a legible
5 postmark bearing a date on or prior to the filing deadline and is in the
6 office of the filing officer no later than seven days after the filing
7 deadline.

8 (2) Any candidate for a township office in a county under township
9 organization, the board of trustees of a village, the board of directors
10 of a reclamation district, the county weed district board, the board of
11 directors of a public power district receiving annual gross revenue of
12 less than forty million dollars, ~~the school board of a Class II school~~
13 ~~district,~~ or the board of an educational service unit may place his or
14 her name on the general election ballot by filing a candidate filing form
15 prescribed by the Secretary of State as provided in section 32-607. If a
16 candidate for an elective office is an incumbent of any elective office,
17 the filing period for filing the candidate filing form shall be between
18 December 1 and July 15 prior to the date of the general election. No
19 incumbent who resigns from elective office prior to the expiration of his
20 or her term shall file for any office after July 15 of that election
21 year. All other candidates shall file for office between December 1 and
22 August 1 prior to the date of the general election. A candidate filing
23 form may be transmitted by facsimile for the offices listed in
24 subdivision (1) of section 32-607 if (a) the transmission is received in
25 the office of the filing officer by the filing deadline and (b) the
26 original filing form is mailed to the filing officer with a legible
27 postmark bearing a date on or prior to the filing deadline and is in the
28 office of the filing officer no later than seven days after the filing
29 deadline.

30 (3) Any city having a home rule charter may provide for filing
31 deadlines for any person desiring to be a candidate for the office of

1 council member or mayor.

2 Sec. 4. Section 32-1007, Reissue Revised Statutes of Nebraska, is
3 amended to read:

4 32-1007 For members of a village board of trustees or ~~,~~ township
5 officers, ~~or members of the school board of Class I or II school~~
6 ~~districts,~~ if a first or generally recognized name and last name of a
7 person is filled in on a line provided for that purpose and the square or
8 oval opposite such line has been marked with a cross or other clear,
9 intelligible mark, the vote shall be valid and the ballot shall be
10 counted. If only the last name of a person is in the write-in space on
11 the ballot and there is more than one person in the county having the
12 same last name, the counting board shall reject the ballot for that
13 office unless the last name is reasonably close to the proper spelling of
14 the last name of a candidate engaged in or pursuing a write-in campaign
15 pursuant to section 32-615. The counting board shall make the following
16 notation on the rejected ballot: Rejected for the office of,
17 no first or generally recognized name.

18 Sec. 5. Section 32-1303, Reissue Revised Statutes of Nebraska, is
19 amended to read:

20 32-1303 (1) A petition demanding that the question of removing an
21 elected official or member of a governing body listed in section 32-1302
22 be submitted to the registered voters shall be signed by registered
23 voters equal in number to at least thirty-five percent of the total vote
24 cast for that office in the last general election, except that (a) for an
25 office for which more than one candidate is chosen, the petition shall be
26 signed by registered voters equal in number to at least thirty-five
27 percent of the number of votes cast for the person receiving the most
28 votes for such office in the last general election, ~~(b) for a member of a~~
29 ~~board of a Class I school district, the petition shall be signed by~~
30 ~~registered voters of the school district equal in number to at least~~
31 ~~twenty-five percent of the total number of registered voters residing in~~

1 ~~the district on the date that the recall petitions are first checked out~~
2 ~~from the filing clerk by the principal circulator,~~ and (b) (c) for a
3 member of a governing body of a village, the petition shall be signed by
4 registered voters equal in number to at least forty-five percent of the
5 total vote cast for the person receiving the most votes for that office
6 in the last general election. The signatures shall be affixed to petition
7 papers and shall be considered part of the petition.

8 (2) Petition circulators shall conform to the requirements of
9 sections 32-629 and 32-630.

10 (3) The petition papers shall be procured from the filing clerk.
11 Prior to the issuance of such petition papers, an affidavit shall be
12 signed and filed with the filing clerk by at least one registered voter.
13 Such voter or voters shall be deemed to be the principal circulator or
14 circulators of the recall petition. The affidavit shall state the name
15 and office of the official sought to be removed, shall include in
16 typewritten form in concise language of sixty words or less the reason or
17 reasons for which recall is sought, and shall request that the filing
18 clerk issue initial petition papers to the principal circulator for
19 circulation. The filing clerk shall notify the official sought to be
20 removed by any method specified in section 25-505.01 or, if notification
21 cannot be made with reasonable diligence by any of the methods specified
22 in section 25-505.01, by leaving a copy of the affidavit at the
23 official's usual place of residence and mailing a copy by first-class
24 mail to the official's last-known address. If the official chooses, he or
25 she may submit a defense statement in typewritten form in concise
26 language of sixty words or less for inclusion on the petition. Any such
27 defense statement shall be submitted to the filing clerk within twenty
28 days after the official receives the copy of the affidavit. The principal
29 circulator or circulators shall gather the petition papers within twenty
30 days after the receipt of the official's defense statement. The filing
31 clerk shall notify the principal circulator or circulators that the

1 necessary signatures must be gathered within thirty days from the date of
2 issuing the petitions.

3 (4) The filing clerk, upon issuing the initial petition papers or
4 any subsequent petition papers, shall enter in a record, to be kept in
5 his or her office, the name of the principal circulator or circulators to
6 whom the papers were issued, the date of issuance, and the number of
7 papers issued. The filing clerk shall certify on the papers the name of
8 the principal circulator or circulators to whom the papers were issued
9 and the date they were issued. No petition paper shall be accepted as
10 part of the petition unless it bears such certificate. The principal
11 circulator or circulators who check out petitions from the filing clerk
12 may distribute such petitions to persons who may act as circulators of
13 such petitions.

14 (5) Petition signers shall conform to the requirements of sections
15 32-629 and 32-630. Each signer of a recall petition shall be a registered
16 voter and qualified by his or her place of residence to vote for the
17 office in question.

18 Sec. 6. Section 48-303, Reissue Revised Statutes of Nebraska, is
19 amended to read:

20 48-303 Except as otherwise provided in this section, an employment
21 certificate shall be approved only by the superintendent of the ~~primary~~
22 ~~high~~ school district in which the child resides or by a person authorized
23 by him or her in writing or, when there is no superintendent, by a person
24 authorized by the school district officers, except that no school
25 district officer or other person authorized by this section may approve
26 such certificate for any child then in or about to enter his or her own
27 employment or the employment of a firm or corporation of which he or she
28 is a member, officer, or employee or in whose business he or she is
29 interested. If a child who resides in an adjoining state seeks to work in
30 Nebraska, the Department of Labor may approve the employment certificate.
31 The officer or person approving such certificate may administer the oath

1 provided for therein or in any investigation or examination necessary for
2 the approval thereof. No fee shall be charged for approving any such
3 certificate or for administering any oath or rendering any services
4 related thereto. The school board or board of education of each school
5 district approving the employment certificate, or the department if the
6 department has approved the employment certificate, shall establish and
7 maintain proper records where copies of all such certificates and all
8 documents connected therewith shall be filed and preserved and shall
9 provide the necessary clerical services for carrying out sections 48-302
10 to 48-313. The person who issued the employment certificate shall report
11 to the department any complaint concerning the conditions of employment
12 of a child for whom a certificate is in force. Upon receipt of the
13 report, the department shall make such investigation as it deems
14 advisable to protect an individual child or to promote the youth-work
15 program.

16 Sec. 7. Section 72-2304, Reissue Revised Statutes of Nebraska, is
17 amended to read:

18 72-2304 (1) In addition to any other borrowing powers provided for
19 by law, a qualified public agency shall have the power to issue its
20 negotiable bonds to any joint entity as defined in section 13-803 or to
21 any joint public agency as defined in section 13-2503 in connection with
22 any joint project which is to be owned, operated, or financed by the
23 joint entity or joint public agency for the benefit of the qualified
24 public agency. The bonds may be issued only if the second largest
25 participant in the joint project has a financial contribution in the
26 joint project of at least twenty-five percent of the debt service. Such
27 bonds may be issued after the qualified public agency has conducted a
28 public hearing on the issuance of bonds. Notice of such public hearing
29 shall be given by publication in a newspaper of general circulation
30 within the territory of the qualified public agency by at least one
31 publication occurring not less than ten days prior to the time of

1 hearing. After the public hearing, the governing body of the qualified
2 public agency may proceed to adopt a bond measure authorizing bonds.

3 (2) Notice of any such bond measure shall be given by publication of
4 notice of intention to issue bonds in a newspaper of general circulation
5 within the territory of the qualified public agency at least twice after
6 the adoption of the bond measure. Such publications shall be at least
7 three weeks apart. The notice shall state:

8 (a) The name of the qualified public agency;

9 (b) The purpose of the issue;

10 (c) The principal amount of the issue;

11 (d) The amount of annual debt service payment anticipated for the
12 bonds, which may be stated as an approximation or estimate, and the
13 anticipated duration for such debt service payments; and

14 (e) The time and place where a copy of the form of the bond measure
15 may be examined for a period of at least thirty days.

16 (3) No election shall be required prior to the issuance of bonds
17 under the Public Facilities Construction and Finance Act unless, within
18 sixty days after the first publication of the notice of intention to
19 issue bonds, a remonstrance petition against the issuance of bonds is
20 filed with the clerk or secretary of the qualified public agency. Such
21 remonstrance petition shall be signed by registered voters of the
22 qualified public agency equal in number to at least five percent of the
23 number of registered voters of the qualified public agency at the time
24 the remonstrance petition is filed or at least the number of signatures
25 listed in subsection (5) of this section for the applicable qualified
26 public agency, whichever is less. If a remonstrance petition with the
27 necessary number of qualified signatures is timely filed, the question
28 shall be submitted to the voters of the qualified public agency at a
29 general election or a special election called for the purpose of
30 approving the bonds proposed to be issued. Any joint project for which
31 bonds are issued in accordance with the procedures of the act shall not

1 require any other approval or proceeding by the governing body or the
2 voters of the qualified public agency.

3 (4) No election shall be required for any qualified public agency
4 not issuing bonds to participate in such joint project unless, within
5 sixty days after the governing body of the qualified public agency adopts
6 the measure approving the interlocal or cooperative agreement related to
7 the joint project, a remonstrance petition is filed with the clerk or
8 secretary of the qualified public agency. Such remonstrance petition
9 shall be signed by registered voters of the qualified public agency equal
10 in number to at least five percent of the number of registered voters of
11 the qualified public agency at the time the remonstrance petition is
12 filed or at least the number of signatures listed in subsection (5) of
13 this section for the applicable qualified public agency, whichever is
14 less. If a remonstrance petition with the necessary number of qualified
15 signatures is timely filed, the question shall be submitted to the voters
16 of the qualified public agency at a general election or a special
17 election called for the purpose of approving the interlocal or
18 cooperative agreement related to the joint project.

19 (5) The chart in this subsection provides the alternative number of
20 signatures of registered voters of a qualified public agency which may be
21 used to submit a remonstrance petition under subsection (3) or (4) of
22 this section. The classification of counties in section 23-1114.01
23 applies for purposes of this section.

20 Sec. 8. Section 77-3444, Reissue Revised Statutes of Nebraska, is
21 amended to read:

22 77-3444 (1) A political subdivision, ~~other than a Class I school~~
23 ~~district,~~ may exceed the limits provided in section 77-3442 or a final
24 levy allocation determination as provided in section 77-3443 by an amount
25 not to exceed a maximum levy approved by a majority of registered voters
26 voting on the issue in a primary, general, or special election at which
27 the issue is placed before the registered voters. A vote to exceed the
28 limits provided in section 77-3442 or a final levy allocation as provided
29 in section 77-3443 must be approved prior to October 10 of the fiscal
30 year which is to be the first to exceed the limits or final levy

1 allocation. The governing body of the political subdivision may call for
2 the submission of the issue to the voters (a) by passing a resolution
3 calling for exceeding the limits or final levy allocation by a vote of at
4 least two-thirds of the members of the governing body and delivering a
5 copy of the resolution to the county clerk or election commissioner of
6 every county which contains all or part of the political subdivision or
7 (b) upon receipt of a petition by the county clerk or election
8 commissioner of every county containing all or part of the political
9 subdivision requesting an election signed by at least five percent of the
10 registered voters residing in the political subdivision. The resolution
11 or petition shall include the amount of levy which would be imposed in
12 excess of the limits provided in section 77-3442 or the final levy
13 allocation as provided in section 77-3443 and the duration of the excess
14 levy authority. The excess levy authority shall not have a duration
15 greater than five years. Any resolution or petition calling for a special
16 election shall be filed with the county clerk or election commissioner no
17 later than thirty days prior to the date of the election, and the time of
18 publication and providing a copy of the notice of election required in
19 section 32-802 shall be no later than twenty days prior to the election.
20 The county clerk or election commissioner shall place the issue on the
21 ballot at an election as called for in the resolution or petition which
22 is at least thirty days after receipt of the resolution or petition. The
23 election shall be held pursuant to the Election Act. For petitions filed
24 with the county clerk or election commissioner on or after May 1, 1998,
25 the petition shall be in the form as provided in sections 32-628 to
26 32-631. Any excess levy authority approved under this section shall
27 terminate pursuant to its terms, on a vote of the governing body of the
28 political subdivision to terminate the authority to levy more than the
29 limits, at the end of the fourth fiscal year following the first year in
30 which the levy exceeded the limit or the final levy allocation, or as
31 provided in subsection (4) of this section, whichever is earliest. A

1 governing body may pass no more than one resolution calling for an
2 election pursuant to this section during any one calendar year. Only one
3 election may be held in any one calendar year pursuant to a petition
4 initiated under this section.

5 (2) The ballot question may include any terms and conditions set
6 forth in the resolution or petition and shall include the following:
7 "Shall (name of political subdivision) be allowed to levy a property tax
8 not to exceed cents per one hundred dollars of taxable
9 valuation in excess of the limits prescribed by law until fiscal
10 year for the purposes of (general operations; building
11 construction, remodeling, or site acquisition; or both general operations
12 and building construction, remodeling, or site acquisition)?" If a
13 majority of the votes cast upon the ballot question are in favor of such
14 tax, the county board shall authorize a tax in excess of the limits in
15 section 77-3442 or the final levy allocation in section 77-3443 but such
16 tax shall not exceed the amount stated in the ballot question. If a
17 majority of those voting on the ballot question are opposed to such tax,
18 the governing body of the political subdivision shall not impose such
19 tax.

20 (3) In lieu of the election procedures in subsection (1) of this
21 section, any political subdivision subject to section 77-3443, ~~other than~~
22 ~~a Class I school district,~~ and villages may approve a levy in excess of
23 the limits in section 77-3442 or the final levy allocation provided in
24 section 77-3443 for a period of one year at a meeting of the residents of
25 the political subdivision or village, called after notice is published in
26 a newspaper of general circulation in the political subdivision or
27 village at least twenty days prior to the meeting. At least ten percent
28 of the registered voters residing in the political subdivision or village
29 shall constitute a quorum for purposes of taking action to exceed the
30 limits or final levy allocation. A record shall be made of the registered
31 voters residing in the political subdivision or village who are present

1 at the meeting. The method of voting at the meeting shall protect the
2 secrecy of the ballot. If a majority of the registered voters present at
3 the meeting vote in favor of exceeding the limits or final levy
