- 1 A BILL FOR AN ACT relating to political subdivisions; to prohibit cities
- 2 and villages and counties from taxing or otherwise regulating the
- 3 use of distributed ledger technology; to define a term; and to
- 4 provide duties for the Revisor of Statutes.
- 5 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. (1) A city or village shall not:
- 2 <u>(a) Impose any tax or fee on the use of distributed ledger</u>
- 3 technology by any person or entity;
- 4 (b) Require any person or entity to obtain from the city or village
- 5 any certificate, license, or permit to use distributed ledger technology;
- 6 or
- 7 (c) Impose any other requirement relating to the use of distributed
- 8 <u>ledger technology by any person or entity.</u>
- 9 (2) Nothing in this section prohibits a city or village from using
- 10 distributed ledger technology in the performance of its powers or duties.
- 11 (3) For purposes of this section, distributed ledger technology
- 12 <u>means an electronic record of transactions or other data which is: (a)</u>
- 13 <u>Uniformly ordered; (b) redundantly maintained or processed by one or more</u>
- 14 <u>computers or machines to guarantee the consistency or nonrepudiation of</u>
- 15 the recorded transactions or other data; and (c) validated by the use of
- 16 cryptography.
- 17 Sec. 2. (1) A county board shall not:
- 18 (a) Impose any tax or fee on the use of distributed ledger
- 19 <u>technology by any person or entity;</u>
- 20 <u>(b) Require any person or entity to obtain from the board any </u>
- 21 certificate, license, or permit to use distributed ledger technology; or
- 22 (c) Impose any other requirement relating to the use of a
- 23 distributed ledger technology by any person or entity.
- 24 (2) Nothing in this section prohibits a county board from using
- 25 distributed ledger technology in the performance of its powers or duties.
- 26 (3) For purposes of this section, distributed ledger technology
- 27 means an electronic record of transactions or other data which is: (a)
- 28 Uniformly ordered; (b) redundantly maintained or processed by one or more
- 29 computers or machines to guarantee the consistency or nonrepudiation of
- 30 the recorded transactions or other data; and (c) validated by the use of
