A BILL FOR AN ACT relating to controlled substances; to amend sections
38-2833, 38-2847, 38-2891, 38-28,106, and 71-425, Reissue Revised
Statutes of Nebraska, sections 71-403, 71-2448, and 71-2483, Revised
Statutes Cumulative Supplement, 2016, and sections 38-2801, 38-2802,
38-2870, 38-2892, and 71-401, Revised Statutes Supplement, 2017; to
define and redefine terms; to provide for licensure of remote
dispensing pharmacies; to provide for remote dispensing; to

harmonize provisions; and to repeal the original sections.

- (2) Prescription drugs or devices may only be dispensed by a 22 pharmacist or pharmacist intern pursuant to a medical order, by an 23 24 individual dispensing pursuant to a delegated dispensing permit, or as 25 otherwise provided in section 38-2850. Notwithstanding any other provision of law to the contrary, a pharmacist or a pharmacist intern may 26 dispense drugs or devices pursuant to a medical order or an individual 27 28 dispensing pursuant to a delegated dispensing permit may dispense drugs or devices pursuant to a medical order. The Pharmacy Practice Act shall 29 not be construed to require any pharmacist or pharmacist intern to 30 dispense, compound, administer, or prepare for administration any drug or 31

- 1 device pursuant to any medical order. A pharmacist or pharmacist intern
- 2 shall retain the professional right to refuse to dispense.
- 3 (3) Except as otherwise provided in sections 28-414 and 28-414.01, a
- 4 practitioner or the practitioner's agent may transmit a medical order to
- 5 a pharmacist or pharmacist intern and an authorized refill to a
- 6 pharmacist, pharmacist intern, or pharmacy technician by the following
- 7 means: (a) In writing, (b) orally, (c) by facsimile transmission of a
- 8 written medical order or electronic transmission of a medical order
- 9 signed by the practitioner, or (d) by facsimile transmission of a written
- 10 medical order or electronic transmission of a medical order which is not
- 11 signed by the practitioner. Such an unsigned medical order shall be
- 12 verified with the practitioner.
- 13 (4)(a) Except as otherwise provided in sections 28-414 and
- 14 28-414.01, any medical order transmitted by facsimile or electronic
- 15 transmission shall:
- (i) Be transmitted by the practitioner or the practitioner's agent
- 17 directly to a pharmacist or pharmacist intern in a licensed pharmacy of
- 18 the patient's choice; and any authorized refill transmitted by facsimile
- 19 or electronic transmission shall be transmitted by the practitioner or
- 20 the practitioner's agent directly to a pharmacist, pharmacist intern, or
- 21 <u>pharmacy technician</u>. No intervening person shall be permitted access to
- 22 the medical order to alter such order or the licensed pharmacy chosen by
- 23 the patient. Such medical order may be transmitted through a third-party
- 24 intermediary who shall facilitate the transmission of the order from the
- 25 practitioner or practitioner's agent to the pharmacy;
- 26 (ii) Identify the transmitter's telephone number or other suitable
- 27 information necessary to contact the transmitter for written or oral
- 28 confirmation, the time and date of the transmission, the identity of the
- 29 pharmacy intended to receive the transmission, and other information as
- 30 required by law; and
- 31 (iii) Serve as the original medical order if all other requirements

- 1 of this subsection are satisfied.
- 2 (b) Medical orders transmitted by electronic transmission shall be
- 3 signed by the practitioner either with an electronic signature for legend
- 4 drugs which are not controlled substances or a digital signature for
- 5 legend drugs which are controlled substances.
- 6 (5) The pharmacist shall exercise professional judgment regarding
- 7 the accuracy, validity, and authenticity of any medical order transmitted
- 8 by facsimile or electronic transmission.

- 12 <u>audiovisual communication system is restored and working properly.</u>
- 13 (3) The remote dispensing pharmacy must have the same pharmacist in
- 14 <u>charge as the supervising pharmacy. The pharmacist in charge must ensure</u>
- 15 that a pharmacist is onsite at the remote dispensing pharmacy at a
- 16 minimum of once each calendar month. The pharmacist in charge in the
- 17 supervising pharmacy may delegate tasks to another pharmacist who is
- 18 employed by the supervising pharmacy, such as supervision of the
- 19 certified pharmacy technician working remotely in the remote dispensing
- 20 pharmacy, oversight of inventory, patient counseling, and other duties as
- 21 assigned. The pharmacist supervising the certified pharmacy technician
- 22 remotely is responsible for the drug utilization review, the final
- 23 <u>verification</u>, and the supervision of the remote dispensing at the remote
- 24 <u>dispensing pharmacy</u>.
- 25 (4) In order for remote dispensing to occur in a remote dispensing
- 26 <u>pharmacy:</u>
- 27 (a) When a prescription is being dispensed to a patient or
- 28 caregiver, the supervising pharmacist must attempt to counsel on all new
- 29 prescriptions dispensed from the remote dispensing pharmacy; and
- 30 (b) The real-time audiovisual communication system must be working
- 31 properly.
