## Annual Report on Paroled Offenders Pursuant to Correctional System Overcrowding Emergency Act: December 2020

Per N.R.S. §83-963, there shall be prepared “an annual report on committed offenders who are paroled or granted controlled release pursuant to the Correctional System Overcrowding Emergency Act.” This report is to summarize each offender’s behavior since parole and their success (or lack thereof) in becoming a law-abiding member of society. This report will provide an aggregate summary of all those paroled between July 1, 2020 and November 30, 2020 as well as an appendix providing de-identified success and progress data on those individuals paroled during this time period. A total of 494 unique offenders were released on parole over those 5 months, with a total of 66 completing their term of supervision during that same period (32 successful, 34 unsuccessful). Of the 494 offenders released, the vast majority remain on supervision without sanctions indicating solid progress toward successful completion of their parole term. A total of 17 individuals out of 494 have served a custodial sanction prior to November 30, 2020; 3 of those individuals had their parole revoked following that custodial sanction. As of December 2020, 446 out of the 494 paroled (90.3%) remain on supervision with no custodial sanction or have already successfully completed their parole supervision term.

### I. AGGREGATE DATA ANALYSIS

- From July 1, 2020 to November 30, 2020, a total of 494 unique offenders were released on parole after commitment to a Nebraska Department of Correctional Services facility. Of that number, 116 were re-paroled (paroled for their second, third, or subsequent term of supervision) and 378 were paroled for the first time.
- Of the 494 unique offenders released, 32 have successfully completed or discharged their term of supervision (31 successful, 1 deceased). These individuals comprise a total of 6.5% of parole releases from July to November 2020.
- A total of 34 individuals paroled on or after July 1, 2020 had their parole revoked on or before November 30, 2020. These individuals comprise a total of 6.9% of parole releases from July to November 2020. Of the 34 with unsuccessful completions, 18 were unsuccessfully discharged for technical violations of their parole term; 16 individuals were unsuccessfully discharged from parole due to new laws violations.
- A total of 428 individuals are still currently on parole supervision following their release. These individuals comprise 86.6% of parole releases from July to November 2020.
- A total of 238 intermediate (non-custodial) sanctions have been issued to 142 different parole clients released between July and November 2020.
- Of the 494 unique offenders released, a total of 14 individuals have been issued a custodial sanction. The average number of days served for a custodial sanction was 20.4.
- As of December 2020, 32 individuals had a status of successful completion, 34 had a status of unsuccessful completion, 14 had a status of progression toward completion of supervision with at least one custodial sanction, and 414 had a status of actively on supervision with no custodial sanction.

The remainder of this report provides an appendix listing each of the 494 individuals on parole with an assessment of individual progress for that client (progressing toward completion of

supervision, successful completion, and unsuccessful completion with notes on the type of violation that led to unsuccessful completion) including counts of intermediate sanctions issued and whether the client was ever issued a custodial sanction. All data has been de-identified with pseudo IDs assigned for all parole clients to ensure appropriate privacy safeguards for those clients. The listing of pseudo IDs was developed and is maintained by the Nebraska Board of Parole/Division of Parole Supervision.
