# **CUSTOMIZED JOB TRAINING**

When it comes to attracting businesses to grow and diversify the Nebraska economy, our state's greatest resource is its people.





Skilled labor availability is a key talking point for firms weighing expansion and relocation decisions. Similarly, companies seeking to launch new products, services and technologies need access to a workforce with the skills and qualifications to support enhanced innovation.

Nebraska's Customized Job Training Program (CJT) promotes the development of human capital to further develop our state's talented, hardworking labor force. CJT provides financial assistance for employee training to businesses seeking to create or retain quality jobs in Nebraska. In doing so, the program incentivizes new investments into the local workforce while spurring innovation and generating new opportunities for Nebraska families.

### The CJT program:

- Supports the recruitment and development of businesses seeking to create high-skill, high-quality jobs in Nebraska.
- Proliferates Nebraska-made innovation by helping existing companies retrain and retool their labor force to support the launch of new products and technologies.
- Incentivizes the creation of full-time positions to spur opportunities for Nebraska individuals and families.
- Adds to the state's export productivity and economic diversity by supporting companies that primarily sell their products and services outside of Nebraska.

CJT-awarded businesses have one to three years to complete training for new or existing employees.

Upon completion, they must maintain their employee baseline, as listed in the CJT application, for a period of at least two years. This includes all new jobs funded through the program.

CJT projects must create jobs, or, due to purchases of new technology or equipment, require the retraining of existing positions in order to retain those positions in Nebraska. Eligible CJT training activities include:

- n On-the-job training
- n Pre-employment training
- n Classroom training, either on-site or at an institute of higher education
- n Training tuition and fees
- n Training materials and equipment
- Costs associated with upgrading the skills of the existing labor force to adapt to new technologies or the introduction of new product lines.

## Customized Job Training 2018 Program Year Allotments and Contracts

DED signed three new CJT contracts in 2018, which will result in the training of 204 employees. In total, 20 CJT contracts were active during 2018, representing \$3,252,875 in awards. These contracts will result in 1,103 new and 40 existing employees being trained. Expenditures to date from year 2018 active contracts are \$2,052,482 (*Table 1.1*).

A total of 11 CJT contracts were closed in 2018. These resulted in the training of 270 new and 75 existing employees, with total expenditures of \$883,379.

Tables 1.1 and 1.2 below provide detailed information on CJT Calendar Year 2018 active and closed grants.

Table 1.3 provides a summary of CJT projected investments for the (in progress) 2019 program year.
