Re: Developmental Disabilities Court-Ordered Custody Act Report

Dear Mr. O'Donnell,

Per Neb. Rev. Stat. §71-1134, the Division of Developmental Disabilities is submitting this communication as the Developmental Disabilities Court-Ordered Custody Act (DDCOCA) annual report for fiscal year 2019/2020.

When an individual has been adjudicated as a person in need of court-ordered custody and treatment under the DDCOCA, the Department of Health and Human Services is required to evaluate the individual and develop a plan for custody and treatment, in the least restrictive alternative. If the court approves the plan, such custody and treatment will continue until an annual review hearing before the same court, where the plan may be continued, revised or discontinued, depending on the circumstances.

During the 2019/2020 fiscal year, \$7,701,890.97 was spent to provide services to individuals affected by the Developmental Disabilities Court Ordered Custody Act from the Division of Developmental Disabilities. Attached is a summary of the cases as well as historical data on this Act since implementation in fiscal year 2014/2015.
