Dear Governor Ricketts, Clerk of the Legislature O'Donnell, and State Senators:

A total of \$3,701,740 million was distributed to Mutual Finance Organizations and Fire Protections Districts across Nebraska in Fiscal Year 2019-2020. The organization reported that most of that aid was used for equipment, supplies, and training to protect and assist their fellow residents in communities across the state.

The use of money distributed in 2019-2020 through the Mutual Finance Assistance Fund is highlighted in the Annual Report to the Legislature, which can be found on the Treasurer's website at https://treasurer.nebraska.gov/tm/rural-fire-district-assistance.aspx. The report also has been electronically filed with the Legislature and can be found on the Nebraska Legislature's website at http://nebraskalegislature.gov/agencies/view.php.

For background, the Mutual Finance Assistance Fund was established by the Legislature in 1998 to provide aid to rural or suburban Fire Protections Districts (FPDs) and Mutual Finance Organizations (MFOs) "for the purpose of financing operational and equipment needs for fire protection, emergency response, or training." The Treasury Management Division of the Treasurer's Office is responsible for receiving applications for these funds and disbursing the funds each year. In 2019-2020, MFOs and FPDs applied for the \$4 million appropriated and a total of \$3,701,740 was disbursed.

<u>ANTELOPE COUNTY MFO</u> - FY 19-20 Air packs, repairs and upgrades to equipment and facilities, EMT training, continuing education, CPR classes, fire school, radios, communication equipment, bunker gear and uniforms.

ARTHUR COUNTY MFO - FY 19-20 Reporting tablet, fire truck intercom system and PPE Turnout gear.

BANNER COUNTY MFO - FY 19-20 Capital improvements, training and gear.

BOONE COUNTY MFO - FY 19-20 New side-by-side for fire and rescue operations, bunker gear and equipment maintenance.

BOX BUTTE COUNTY MFO - FY 19-20 Operational, equipment needs and training.

BROWN COUNTY MFO - FY 19-20 Capital improvements, equipment purchases, and protective gear.

BURT COUNTY MFO - FY 19-20 Salaries, training expenses, repairs and maintenance.

<u>DAWSON COUNTY MFO</u> - FY 19-20 Equipment, radios, truck, Gator side by side, operating expenses, maintenance, repairs, insurance premiums, grass fire truck, grass 4x4 rig, training, bunker gear, air bags, jaws of life, utility bills and Quick Attack Rig.

<u>GAGE COUNTY MFO</u> – FY 19-20 Handheld radios, pagers, fire helmets, turnout gear, fire hose, training manuals, ventilation saw, pumper truck payment, grass rig, forcible entry tools, flashlights fire nozzles and self-contained breathing apparatus.

GARFIELD COUNTY MFO - FY 19-20 Training expenses, repairs and maintenance.

GRANT COUNTY MFO – FY 19-20 Helmets, googles and extrication tool.

HOOKER COUNTY MFO - FY 19-20 Protective gear, equipment and training.

<u>JEFFERSON COUNTY MFO</u> - FY 19-20 Building addition, ambulance, air packs, air pack tanks, bunker gear, wildland gear, water tanker truck and fire truck

JOHNSON COUNTY MFO - -FY 19-20 Insurance, fuel, maintenance and equipment.

KEYA PAHA COUNTY MFO - FY 19-20 Purchase of fuel and repairs for fire trucks.

KNOX COUNTY MFO - FY 19-20 Firefighting equipment and supplies.

<u>LINCOLN COUNTY MFO</u> - FY 19-20 Programs, equipment, pumpers, SCBA's, equipment repairs, wildland gear, hydrants, air packs, structural gear, water appliances, bunker gear, pump tests, boots, helmets bunker gear and stretcher.

LOGAN COUNTY MFO - FY 19-20 Repairs to equipment, training and general expenses.

<u>MADISON COUNTY MFO</u> - FY 19-20 Radios, Haz-Mat equipment, fire hose, self-contained breathing apparatus, bunker gear, rescue supplies, trainings props and hand tools.

<u>MCPHERSON COUNTY MFO</u> - FY 19-20 Radio service, fire and EMT training and purchase of fire and ambulance equipment.

<u>MERRICK COUNTY MFO</u> – Bunker gear, Tecgen gear, hoses, pagers, glass cutter, pagers, rig updates and thermal imaging camera.

NANCE COUNTY MFO - FY 19-20 Bunker gear and maintenance of equipment.

NEMAHA COUNTY MFO - FY 19-20 Insurance, utilities, building maintenance, equipment, fuel and equipment maintenance

PAWNEE COUNTY MFO - FY 19-20 Supplies, fuel, maintenance, equipment, insurance and repairs.

<u>PHELPS COUNTY MFO</u> - FY 19-20 Fire protective gear, fire truck equipment, communication equipment, travel expenses, fire prevention week materials, repairs to equipment, maintenance of fire halls, insurance utilities, debt service and property tax relief.

PIERCE COUNTY MFO - FY 19-20 Bunker gear, handheld radios and air compressor to fill air bottles.

<u>POLK COUNTY MFO</u> - FY 19-20 Bunker gear, truck, radios, truck outfitting, rescue gear, batteries, pagers, charging station, hose, fire school and reg updates.

<u>RED WILLOW COUNTY MFO</u> - FY 19-20 Rechargeable batteries, aerator, bulbs, safety silicon full face piece, fire school, annual ambulance payment, oxygen/mega mover blanket, compressor maintenance, extractor, pump, radios, wild land boots, apparatus and personnel.

<u>RICHARDSON COUNTY MFO</u> - FY 19-20 Salaries, fuel, insurance, repairs, worker's comp insurance, utilities, fire building repairs, propane and CPA fees

ROCK COUNTY MFO - FY 19-20 Maintenance, insurance and training.

<u>SALINE COUNTY MFO</u> - FY 19-20 Fire truck payments, firefighter protection gear, equipment repairs and improvements, capital improvement payments, new capital purchases and professional cleaning of bunker gear.

<u>SAUNDERS COUNTY MFO</u> - FY 19-20 Nozzles, thermal image cameras, hoses, skid unit, bunker gear, water holding tank for tanker truck, control system for wells and water tower, insurance, new siren, power lift for Stryker cot, rope rescue equipment, radio system, commercial washer and dryer, large equipment payments and building improvements.

<u>SCOTTS BLUFF COUNTY MFO</u> - FY 19-20 Apparatus, capital improvements, PPE equipment, fire hose, fire nozzles, fire truck, wildland engine, two new tenders and other equipment.

SEWARD COUNTY MFO - FY 19-20 Pagers, radios, extrication, bunker gear, hose, foam and new equipment.

<u>THOMAS COUNTY MFO</u> - FY 19-20 Bunker gear and wildland gear including helmets, Nomex hoods, gloves, goggles, boots, coat and pants.

<u>WAYNE COUNTY MFO</u> - FY 19-20 Training, insurance, utilities, fuel, bunker gear, air packs, radios and ambulance.
