LB 1016 amends the Nebraska Wage Payment and Collection Act.

Section 2 prohibits an employer from retaliating or discriminating against an employee because the employee files a suit or complaint under the Nebraska Wage Payment and Collection act or testifies, assists, or participated in an investigation, proceeding or action concerning violations of the act.

Section 3 addresses relief for employees aggrieved under the act.

Section 4 prohibits employers who have an unpaid citation for a violation under the act from contracting with the state or any political subdivision until the citation is paid.

Section 5 requires the Department of Labor, no later than December 1 of each year, to post information on its web site regarding compliance and enforcement of the act.
