Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 1152 would revise sections of law governing the Nebraska Hemp Farming Act and the Nebraska Hemp Commission. The Department of Agriculture notes that no additional funding would be required to carry out LB 1152 if the agency's request for an additional \$200,000 in cash funding is approved by the Legislature. The Appropriations Committee's preliminary recommendation includes the Department's request for increased funding. LB 1152 also includes legislative intent language to provide \$50,000 in General Funds in both FY20-21 and FY21-22 to the Department of Agriculture to supplement the fees collected under the act.

LB 1152 also amends a section of law governing the appointment of members to the Nebraska Hemp Commission. Section 2-517, which governs the creation of the Commission, becomes effective on July 1, 2021. LB 1152 specifies that the members of the Commission be appointed no later than sixty days after the operative date of the section and conduct its first meeting no less than thirty days after the appointment of the Commission. It is estimated that these revisions would have no fiscal impact upon the Commission.
