Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB1186 would give school employees that have been injured at work up to 7 days of injury leave and would be paid their full salaries for the time off taken for this leave. The Nebraska Workers' Compensation Act would then cover any time past the first seven days. This new type of leave would not have any impact on the employee's other types of paid time off. School districts will report the number of these incidents annually to the Nebraska Department of Education.

EXPENDITURES:

For FY 2020-21, the Nebraska Department of Education estimates a minimal increase in operating expenses to update their system with additional reporting fields to handle the creation, implementation, and also to store responses in for when the districts submit their annual report. There may also be some additional costs to the school districts that cannot be calculated at this time due to not knowing if or when an employee will need to use this new type of paid time off.
