The Supreme Court states that the bill could affect the availability of services to inmates while in prison but that will be on post-release supervision (PRS) when released from prison. This could result in increased and/or more intense services while someone is on PRS. This could result in additional expenditures related to PRS, but any such amount cannot be determined at this time.

The Board of Parole estimates no significant impact from this bill.

The Department of Correctional Services states that the requirements of the bill can be met using existing resources.
