Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

LB 223 establishes the Adjutant General of the Nebraska National Guard as the official sponsor of the existing life-insurance program that is currently operated by the National Guard Association of Nebraska. The bill would also statutorily compel the Adjutant General to:

- Allow, coordinate, and facilitate efforts in making the program available to guard members.
- Provide an opportunity for guard members to purchase life-insurance products through the program.
- Allow, coordinate, and facilitate request allotments with the applicable federal partners.
- Allow program representatives to provide education and product briefings during annual training and inactive duty.
- Allow guard members to designate/change beneficiaries.

The fiscal impact lies with the duties that are placed upon the Adjutant General as bulleted above. Based upon the agency's estimate, there is a need for 0.5 FTE to fulfill the duties related to the coordination and administration of the program. The agency has determined the position would be classified as an Administrative Assistant I; costs for wages, benefits, and operations total \$32,604 in FY20 and \$30,172. There is no basis to disagree with the agency's fiscal note (see attached).
