LB 369, as currently written, requires that the Auditor of Public Accounts may conduct audit of law enforcement agency or jail or the political subdivision who have become a party to an agreement to enforce immigration law beginning September 15, 2019. All additional audit expenses shall be paid by the political subdivision or State Patrol. Any work necessary will be absorbed using the existing appropriations of Agency 010, Auditor of Public Accounts - cash fund, program 525, At this time, there would be no additional fiscal impact to Agency 010-Auditor of Public Accounts.
