**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

LB 378 exempts persons 21 years of age or older who are operating or a passenger on an autocycle, a motorcycle, or moped from wearing a protective helmet. A requirement for autocycle, motorcycle, and moped operators to wear eye protection is placed in statute.

A one-time potential fiscal impact is present as the Department of Transportation (DOT) would need to update signage at border crossings to reflect a change in the helmet law, this amount is indeterminate.

The DOT has provided a fiscal note (see attached) that indicates no fiscal impact is anticipated. In 2018, the DOT provided a fiscal note for a nearly identical bill (LB 368) and it was indicated there would be a one-time \$23,000 cost for modifying signs at state border crossings to reflect the change in the helmet law, but that it could have been absorbed by the department without a change in their appropriation.
