LB 592 amends the Nebraska Liquor Control Act to provide the Nebraska Liquor Control Commission discretion to suspend sales of alcoholic liquor for up to 48 hours for licensees who violate the act within four years after an initial suspension. Current law limits suspension of sales under this subsection for violations related to sales to or possession by a minor.

This bill is not estimated to have a fiscal impact to the state.
