**Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.**

This bill, as amended by AM1635 and AM1961, creates new criminal offenses and also changes provisions of current criminal offenses. Misdemeanor and felony penalties are imposed for violating various provisions of the bill.

Therefore, the bill could potentially increase the number of persons sentenced to prison or county jails. This could increase the incarcerated population and costs to both the state and counties. Any impact is not known at this time.

Both the misdemeanor and felony penalties under this bill also carry the possibility of a fine being imposed. Any fines assessed pursuant to convictions will accrue to the county where the violation occurs to be used for the support of public schools.

The Supreme Court states that the bill, as amended by AM1635 and AM1961, will require judicial education, but they will not require any additional resources at this time.

The Board of Parole estimates no significant impact from this bill, as amended by AM1961.

The Department of Correctional Services states that there could be a possible fiscal impact from this bill as amended by AM1635 and AM1961, but any impact is indeterminable at this time.
