Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill, as amended by AM1537, would adopt the Uniform Civil Remedies for Unauthorized Disclosure of Intimate Images Act.

The Supreme Court estimates a minimal fiscal impact from the provisions of this bill, as amended by AM1537.

The Court notes that AM1537 removes the previous Cash Fund impact related to JUSTICE modifications because it removes language relating to redaction of documents, uses existing statutory language regarding the use of pseudonyms, and an assumption that these cases will be limited.

Explanation of Estimate:

LB680, as amended by AM1537, would have a minimal fiscal impact to provide additional education and training regarding statutory changes. AM1537 removes the previous Cash Fund impact related to JUSTICE modification due to:

1. Removal of the language related to redaction of documents.
2. Use of existing statutory language which allows judicial discretion regarding the use of pseudonyms.
3. An assumption that the number of court cases related to these statutes will be limited.
