LB 693 is the Neighbor Spoofing Protection Act.

The bill prohibits any person to sell, rent, or convey any interest in a telephone number to any out-of-state person unless such telephone number is listed or available from directory assistance to the general public so that a member of the general public could determine the source of the telephone number by contacting his or her telecommunications provider.

The bill also prohibits any person, in connection with any telecommunications service or IP-enabled voice service, from causing any caller identification service to knowingly transmit misleading or inaccurate caller identification information with the intent to defraud, cause harm, or wrongfully obtain anything of value.

The Public Service Commission estimates no fiscal impact.
