LB6 changes student residency requirements for public postsecondary institutions. LB6 provides that if a student was on active duty assignment in Nebraska at the time the student was accepted for admission and has remained continually enrolled, then that student would be considered a resident for tuition purposes. Currently the student must be on active duty. LB6 also provides that the spouse of a student that was on active duty at the time the student was accepted for admission is also to be considered a resident.

The University of Nebraska and the Nebraska State College System indicate no fiscal impact. The Nebraska Community Colleges estimate minimal fiscal impact at \$36,000.
