Any Fiscal Notes received from state agencies and political subdivisions are attached following the Legislative Fiscal Analyst Estimate.

This bill would provide for intervention by a biological parent in certain juvenile proceedings.

AM422 states that the costs of genetic testing shall be paid by the intervenor, the county, or the state at the discretion of the juvenile court. This provision has the potential for additional costs being paid by a county or the state. Because it is at the discretion of the juvenile court, any impact is indeterminable at this time.

The Supreme Court estimates a minimal fiscal impact to provide education related to the changes in AM422.

The Supreme Court notes that if the cost of the genetic test is to be paid by the "state", it assumes that it would not be the Court that paid, but an entity such as the Department of Health and Human Services (HHS).

HHS stated that the introduced copy of this bill had no fiscal impact to them. However, the introduced copy had the costs of the genetic test paid only by the intervenor, not the state or county. HHS has not responded to AM422. If they respond, this fiscal note may be updated.
