## **LEGISLATIVE BILL 48**

FINAL READING

- 1 A BILL FOR AN ACT relating to water; to amend section 46-229.04, Reissue
- 2 Revised Statutes of Nebraska; to change provisions relating to a
- 3 finding of sufficient cause for nonuse of a water appropriation; and
- 4 to repeal the original section.
- 5 Be it enacted by the people of the State of Nebraska,

Section 1. Section 46-229.04, Reissue Revised Statutes of Nebraska,
 is amended to read:

3 46-229.04 (1) At a hearing held pursuant to section 46-229.03, the verified field investigation report of an employee of the department, or 4 5 such other report or information that is relied upon by the department to reach the preliminary determination of nonuse, shall be prima facie 6 7 evidence for the forfeiture and annulment of such water appropriation. If no person appears at the hearing, such water appropriation or unused part 8 9 thereof shall be declared forfeited and annulled. If an interested person appears and contests the same, the department shall hear evidence, and if 10 it appears that such water has not been put to a beneficial use or has 11 ceased to be used for such purpose for more than five consecutive years, 12 the same shall be declared canceled and annulled unless the department 13 14 finds that (a) there has been sufficient cause for such nonuse as provided for in subsection (2), (3), or (4) of this section or (b) 15 subsection (5) or (6) of this section applies. 16

17 (2) Sufficient cause for nonuse shall be deemed to exist for up to
18 thirty consecutive years if:

19 (a) Such such nonuse was caused by the unavailability of water for that use. For a river basin, subbasin, or reach that has been designated 20 as overappropriated pursuant to section 46-713 or determined by the 21 department to be fully appropriated pursuant to section 46-714, the 22 23 period of time within which sufficient cause for nonuse because of the 24 unavailability of water may be deemed to exist may be extended beyond 25 thirty years by the department upon petition therefor by the owner of the appropriation if the department determines that an integrated management 26 plan being implemented in the river basin, subbasin, or reach involved is 27 28 likely to result in restoration of a usable water supply for the appropriation; or -29

30 <u>(b) The land subject to the appropriation is under an acreage</u> 31 reserve program or production quota or is otherwise withdrawn from use as

required for participation in any federal, state, or natural resources district program, or such land was previously under such a program but currently is not under such a program and there have been not more than five consecutive years of nonuse on such land subsequent to when that land was last under such program.

6 (3) Sufficient cause for nonuse shall be deemed to exist 7 indefinitely if such nonuse was the result of one or more of the 8 following:

9 (a) For any tract of land under separate ownership, the available 10 supply was used but on only part of the land under the appropriation 11 because of an inadequate water supply;

(b) The appropriation is a storage appropriation and there was an inadequate water supply to provide the water for the storage appropriation or less than the full amount of the storage appropriation was needed to keep the reservoir full; or

(c) The appropriation is a storage-use appropriation and there was
 an inadequate water supply to provide the water for the appropriation or
 use of the storage water was unnecessary because of climatic conditions.

(4) Sufficient cause for nonuse shall be deemed to exist for up to
fifteen consecutive years if such nonuse was a result of one or more of
the following:

(a) Federal, state, or local laws, rules, or regulations temporarily
prevented or restricted such use;

24 (b) Use of the water was unnecessary because of climatic conditions;

(c) Circumstances were such that a prudent person, following the principles of good husbandry, would not have been expected to use the water;

(d) The works, diversions, or other facilities essential to use the
water were destroyed by a cause not within the control of the owner of
the appropriation and good faith efforts to repair or replace the works,
diversions, or facilities have been and are being made;

(e) The owner of the appropriation was in active involuntary service
 in the armed forces of the United States or was in active voluntary
 service during a time of crisis; or

4 (f) Legal proceedings prevented or restricted use of the water. ; or
5 (g) The land subject to the appropriation is under an acreage
6 reserve program or production quota or is otherwise withdrawn from use as
7 required for participation in any federal or state program or such land
8 previously was under such a program but currently is not under such a
9 program and there have been not more than five consecutive years of
10 nonuse on that land since that land was last under that program.

11 The department may specify by rule and regulation other 12 circumstances that shall be deemed to constitute sufficient cause for 13 nonuse for up to fifteen years.

(5) When an appropriation is held in the name of an irrigation 14 district, a reclamation district, a public power and irrigation district, 15 a mutual irrigation company or canal company, or the United States Bureau 16 17 of Reclamation and the director determines that water under that appropriation has not been used on a specific parcel of land for more 18 than five years and that no sufficient cause for such nonuse exists, the 19 right to use water under that appropriation on that parcel shall be 20 terminated and notice of the termination shall be posted on the 21 22 department's web site and shall be given in the manner provided in subsection (2), (3), or (4) of section 46-229.03. The district or company 23 24 holding such right shall have five years after the determination, or five 25 years after an order of cancellation issued by the department following the filing of a voluntary relinquishment of the water appropriation that 26 has been signed by the landowner and the appropriator of record, to 27 assign the right to use that portion of the appropriation to other land 28 within the district or the area served by the company, to file an 29 application for a transfer in accordance with section 46-290, or to 30 transfer the right in accordance with sections 46-2,127 to 46-2,129. The 31

department shall issue its order of cancellation within sixty days after 1 receipt of the voluntary relinquishment unless the relinquishment is 2 conditioned by the landowner upon an action of a governmental agency. If 3 the relinquishment contains such a provision, the department shall issue 4 5 its order of cancellation within sixty days after receipt of notification that such action has been completed. The department shall be notified of 6 any such assignment within thirty days after such assignment. If the 7 8 district or company does not assign the right to use that portion of the 9 appropriation to other land, does not file an application for a transfer within the five-year period, or does not notify the department within 10 thirty days after any such assignment, that portion of the appropriation 11 shall be canceled without further proceedings by the department and the 12 district or company involved shall be so notified by the department. 13 During the time within which assignment of a portion of an appropriation 14 is pending, the allowable diversion rate for the appropriation involved 15 16 shall be reduced, as necessary, to avoid inconsistency with the rate allowed by section 46-231 or with any greater rate previously approved 17 for such appropriation by the director in accordance with section 18 19 46-229.06.

(6) When it is determined by the director that an appropriation, for 20 which the location of use has been temporarily transferred in accordance 21 with sections 46-290 to 46-294, has not been used at the new location for 22 more than five years and that no sufficient cause for such nonuse exists, 23 24 the right to use that appropriation at the temporary location of use shall be terminated. Notice of that termination shall be posted on the 25 department's web site and shall be given in the manner provided in 26 subsection (2), (3), or (4) of section 46-229.03. The right to reinitiate 27 use of that appropriation at the location of use prior to the temporary 28 transfer shall continue to exist for five years after the director's 29 determination, but if such use is not reinitiated at that location within 30 such five-year period, the appropriation shall be subject to cancellation 31

1 in accordance with sections 46-229 to 46-229.04.

2 (7) If at the time of a hearing conducted in accordance with 3 subsection (1) of this section there is an application for incidental or 4 intentional underground water storage pending before the department and 5 filed by the owner of the appropriation, the proceedings shall be 6 consolidated.
