- 1 A BILL FOR AN ACT relating to county and local government; to amend sections 23-1112 and 23-1112.01, 2 Reissue Revised Statutes of 3 13-2203, Nebraska, and section Revised Statutes Cumulative Supplement, 2018; to change provisions relating to reimbursement of 4 mileage and travel expenses; to harmonize provisions; and to repeal 5 6 the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

1 Section 1. Section 13-2203, Revised Statutes Cumulative Supplement,

- 2 2018, is amended to read:
- 3 13-2203 In addition to other expenditures authorized by law, each
- 4 governing body may approve:
- 5 (1)(a) The expenditure of public funds for the payment or
- 6 reimbursement of actual and necessary expenses incurred by elected and
- 7 appointed officials, employees, or volunteers at educational workshops,
- 8 conferences, training programs, official functions, hearings, or
- 9 meetings, whether incurred within or outside the boundaries of the local
- 10 government, if the governing body gave prior approval for participation
- 11 or attendance at the event and for payment or reimbursement either by the
- 12 formal adoption of a uniform policy or by a formal vote of the governing
- 13 body. Authorized expenses may include:
- (i) Registration costs, tuition costs, fees, or charges;
- 15 (ii) Mileage at the rate allowed by section 81-1176 for travel by
- 16 personal automobile, but if travel by rental vehicle or commercial or
- 17 <u>charter means is economical and practical, then authorized expenses shall</u>
- 18 include only the actual cost of the rental vehicle or commercial or
- 19 charter means. The governing body may establish different mileage rates
- 20 <u>based on whether the personal automobile usage is at the convenience of</u>
- 21 the local government or at the convenience of the local government's
- 22 elected or appointed official, employee, or volunteer or actual travel
- 23 expense if travel is authorized by commercial or charter means; and
- 24 (iii) Meals and lodging at a rate not exceeding the applicable
- 25 federal rate unless a fully itemized claim is submitted substantiating
- 26 the costs actually incurred in excess of such rate and such additional
- 27 expenses are expressly approved by the governing body; and
- 28 (b) Authorized expenditures shall not include expenditures for meals
- 29 of paid members of a governing body provided while such members are
- 30 attending a public meeting of the governing body unless such meeting is a
- 31 joint public meeting with one or more other governing bodies;

- 1 (2) The expenditure of public funds for:
- 2 (a) Nonalcoholic beverages provided to individuals attending public
- 3 meetings of the governing body; and
- 4 (b) Nonalcoholic beverages and meals:
- 5 (i) Provided for any individuals while performing or immediately
- 6 after performing relief, assistance, or support activities in emergency
- 7 situations, including, but not limited to, tornado, severe storm, fire,
- 8 or accident;
- 9 (ii) Provided for any volunteers during or immediately following
- 10 their participation in any activity approved by the governing body,
- 11 including, but not limited to, mowing parks, picking up litter, removing
- 12 graffiti, or snow removal; or
- 13 (iii) Provided at one recognition dinner each year held for elected
- 14 and appointed officials, employees, or volunteers of the local
- 15 government. The maximum cost per person for such dinner shall be
- 16 established by formal action of the governing body, but shall not exceed
- 17 fifty dollars. An annual recognition dinner may be held separately for
- 18 employees of each department or separately for volunteers, or any of them
- in combination, if authorized by the governing body; and
- 20 (3) The expenditure of public funds for plaques, certificates of
- 21 achievement, or items of value awarded to elected or appointed officials,
- 22 employees, or volunteers, including persons serving on local government
- 23 boards or commissions. Before making any such expenditure, the governing
- 24 body shall, by official action after a public hearing, establish a
- 25 uniform policy which sets a dollar limit on the value of any plaque,
- 26 certificate of achievement, or item of value to be awarded. Such policy,
- 27 following its initial adoption, shall not be amended or altered more than
- 28 once in any twelve-month period.
- 29 Sec. 2. Section 23-1112, Reissue Revised Statutes of Nebraska, is
- 30 amended to read:
- 31 23-1112 When it is necessary for any county officer or his or her

- 1 deputy or assistants, except any county sheriff or his or her deputy, to
- 2 travel on business of the county, he or she shall be allowed mileage at
- 3 the rate per mile allowed by section 81-1176 for travel by personal
- 4 automobile upon the presentation of his or her bill for the same
- 5 <u>accompanied by a proper voucher to the county board of his or her county</u>
- 6 <u>in like manner as is provided for all other claims against the county,</u>
- 7 but if travel by rental vehicle or commercial or charter means is
- 8 economical and practical, then he or she shall be allowed only the actual
- 9 cost of the rental vehicle or commercial or charter means. The county
- 10 board may establish different mileage rates based on whether the personal
- 11 <u>automobile usage is at the convenience of the county or at the</u>
- 12 convenience of the county officer or his or her deputy or assistant for
- 13 each mile actually and necessarily traveled by the most direct route if
- 14 the trip or trips are made by automobile. If travel by rail or bus is
- 15 economical and practical, he or she shall be allowed only the actual cost
- 16 of rail or bus transportation upon the presentation of his or her bill
- 17 for the same accompanied by a proper voucher to the county board of his
- 18 or her county in like manner as is provided for as to all other claims
- 19 against the county.
- 20 Sec. 3. Section 23-1112.01, Reissue Revised Statutes of Nebraska, is
- 21 amended to read:
- 22 23-1112.01 If a trip or trips included in an expense claim filed by
- 23 any county officer or employee for mileage are made by personal
- 24 automobile or otherwise, only one mileage claim shall be allowed pursuant
- 25 to section 23-1112 at the rate established in section 81-1176, for each
- 26 mile actually and necessarily traveled by the most direct route,
- 27 regardless of the fact that one or more persons are transported in the
- 28 motor vehicle. No charge for mileage shall be allowed when such mileage
- 29 accrues while using any motor vehicle owned by the State of Nebraska or
- 30 by a county.
