- 1 A BILL FOR AN ACT relating to highways and bridges; to amend sections 2 39-1351, 39-1352, and 39-1354, Reissue Revised Statutes of Nebraska, 3 and section 39-1353, Revised Statutes Cumulative Supplement, 2018; 4 to change provisions relating to construction contract bidding, qualification, evaluation, and proposals; to change certification of 5 6 financial showing as prescribed; to change provisions relating to 7 obtaining contract plans prepared by the Department of Transportation; and to repeal the original sections.
- 9 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 39-1351, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 39-1351 (1) Except as provided in subsection (2) of this section,
- 4 any person desiring to submit to the department a bid for the performance
- 5 of any contract for the construction, reconstruction, improvement,
- 6 maintenance, or repair of roads, bridges, and their appurtenances, which
- 7 the department proposes to let, shall apply to the department for
- 8 prequalification. Such application shall be made not later than five ten
- 9 days before the letting of the contract unless fewer than five days is
- 10 specified by the department. The department shall determine the extent of
- 11 any applicant's qualifications by a full and appropriate evaluation of
- 12 the applicant's experience, bonding capacity as determined by a bonding
- 13 agency licensed to do business in the State of Nebraska or other
- 14 <u>sufficient financial showing deemed satisfactory by the department</u>
- 15 equipment, financial resources, and performance record. In determining
- 16 the qualification of an applicant persons to bid on any particular
- 17 contract, the department shall consider the equipment and resources
- 18 available for the particular contract contemplated.
- 19 (2) The department may, in its sole discretion, grant an exemption
- 20 from all prequalification requirements for (a) any contract for the
- 21 construction, reconstruction, improvement, maintenance, or repair of
- 22 roads, bridges, and their appurtenances if the estimate of the department
- 23 for such work is one hundred thousand dollars or less or (b) any contract
- 24 for the construction, reconstruction, improvement, maintenance, or repair
- 25 of roads, bridges, and their appurtenances if such work is of an
- 26 emergency nature.
- 27 Sec. 2. Section 39-1352, Reissue Revised Statutes of Nebraska, is
- 28 amended to read:
- 29 39-1352 (1) Except as provided in subsection (2) of this section,
- 30 any person proposing to bid on a contract for the construction,
- 31 reconstruction, improvement, maintenance, or repair of roads, bridges,

- 1 and their appurtenances to be let by the department shall submit to the
- 2 department, at such times as it may require, a statement showing such
- 3 person's qualifications. Such statement shall be under oath and on a
- 4 standard form to be prepared and supplied by the department. The
- 5 financial showing required in the statement shall be certified by a
- 6 certified public accountant or by a public accountant holding a currently
- 7 valid permit from the Nebraska State Board of Public Accountancy. The
- 8 statement shall be confidential and only for the use of the department.
- 9 (2) Subsection (1) of this section shall not apply to any contract
- 10 granted an exemption from prequalification requirements pursuant to
- 11 subsection (2) of section 39-1351.
- 12 Sec. 3. Section 39-1353, Revised Statutes Cumulative Supplement,
- 13 2018, is amended to read:
- 14 39-1353 (1) Any person desiring to bid Proposal forms for submitting
- 15 bids on any contract for the construction, reconstruction, improvement,
- 16 maintenance, or repair of roads, bridges, and their appurtenances to be
- 17 let by the department shall request an authorization to bid from be
- 18 issued by the department at the offices of the department in Lincoln,
- 19 Nebraska, or at such other location as designated by the department not
- 20 later than 5 p.m. of the day before the letting of the contract.
- 21 (2) Such <u>authorization</u> proposal forms shall be issued only to those
- 22 persons previously qualified by the department and bids shall be accepted
- 23 only from such qualified persons. This subsection shall not apply to any
- 24 contract granted an exemption from prequalification requirements pursuant
- to subsection (2) of section 39-1351.

- 28 39-1354 The department, in its discretion, may provide paper or
- 29 <u>electronic</u> reproductions of the plans prepared by the department for any
- 30 contract to be let for the construction, reconstruction, improvement,
- 31 maintenance, or repair of roads, bridges, and their appurtenances, to any

- 1 person desiring such <u>paper or electronic</u> reproductions. Such person shall
- 2 pay to the department a reasonable sum, to be fixed by the department in
- 3 an amount estimated to cover the actual cost of preparing such paper or
- 4 <u>electronic reproductions</u> a reproduction.
- 5 Sec. 5. Original sections 39-1351, 39-1352, and 39-1354, Reissue
- 6 Revised Statutes of Nebraska, and section 39-1353, Revised Statutes
- 7 Cumulative Supplement, 2018, are repealed.
