- 1 A BILL FOR AN ACT relating to vapor products; to amend sections 28-1418, 28-1418.01, 28-1419, 28-1420, 28-1421, 28-1423, 28-1424, 28-1425, 2 28-1427, 28-1429.01, 28-1429.02, 71-5716, 71-5718, and 71-5727, 3 4 Reissue Revised Statutes of Nebraska; to change and provide 5 restrictions relating to the sale and use of vapor products and flavored liquids as prescribed; to define and redefine terms; to 6 require sellers of vapor products to be licensed as prescribed; to 7 8 change legislative findings; to add restrictions relating to vapor 9 products under the Nebraska Clean Indoor Air Act; to harmonize 10 provisions; to provide an operative date; and to repeal the original
- 12 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 28-1418, Reissue Revised Statutes of Nebraska, is
- 2 amended to read:
- 3 28-1418 (1) Whoever, being a minor under the age of eighteen years,
- 4 shall smoke cigarettes or cigars, use vapor products or alternative
- 5 nicotine products, or use tobacco in any form whatever, in this state,
- 6 shall be guilty of a Class V misdemeanor.
- 7 (2) Whoever, being an individual under the age of twenty-one years,
- 8 <u>shall use vapor products in this state shall be guilty of a Class V</u>
- 9 <u>misdemeanor</u>.
- 10 (3) Any <u>individual minor</u> charged with a violation of this section
- 11 may be free from prosecution if he or she furnishes evidence for the
- 12 conviction of the person or persons selling or giving him or her the
- 13 cigarettes, cigars, vapor products, alternative nicotine products, or
- 14 tobacco.
- 15 Sec. 2. Section 28-1418.01, Reissue Revised Statutes of Nebraska, is
- 16 amended to read:
- 17 28-1418.01 For purposes of sections 28-1418 to 28-1429.03:
- 18 (1) Alternative nicotine product means any noncombustible product
- 19 containing nicotine that is intended for human consumption, whether
- 20 chewed, absorbed, dissolved, or ingested by any other means. Alternative
- 21 nicotine product does not include any vapor product, cigarette, cigar, or
- 22 other tobacco product, or any product regulated as a drug or device by
- 23 the United States Food and Drug Administration under Chapter V of the
- 24 federal Food, Drug, and Cosmetic Act;
- 25 (2) Flavored liquid means a liquid that (a) is composed of nicotine
- 26 <u>and other chemicals, (b) is intended to be used in a vapor product, and</u>
- 27 <u>(c) contains a natural or artificial constituent or additive that causes</u>
- 28 the liquid or its smoke to have a distinguishable flavor or aroma,
- 29 <u>including</u>, but not limited to, chocolate, vanilla, honey, cocoa, or any
- 30 fruit, candy, dessert, alcoholic beverage, herb, or spice;
- 31 (3) (2) Self-service display means a retail display that contains a

- 1 tobacco product, a tobacco-derived product, a vapor product, or an
- 2 alternative nicotine product and is located in an area openly accessible
- 3 to a retailer's customers and from which such customers can readily
- 4 access the product without the assistance of a salesperson. Self-service
- 5 display does not include a display case that holds tobacco products,
- 6 vapor products, or alternative nicotine products behind locked doors;
- 7 (4) (3) Tobacco specialty store means a retail store that (a)
- 8 derives at least seventy-five percent of its revenue from tobacco
- 9 products, tobacco-derived products, vapor products, or alternative
- 10 nicotine products and (b) does not permit minors under the age of
- 11 eighteen years to enter the premises unless accompanied by a parent or
- 12 legal guardian; and
- 13 (5) (4) Vapor product means any noncombustible product, whether
- 14 containing nicotine or not, that employs a heating element, power source,
- 15 electronic circuit, or other electronic, chemical, or mechanical means,
- 16 regardless of shape or size, that can be used to produce vapor from
- 17 nicotine in a solution or other form. Vapor product includes any
- 18 electronic cigarette, electronic cigar, electronic cigarillo, electronic
- 19 pipe, or similar product or device and any vapor cartridge or other
- 20 container of nicotine in a solution or other form that is intended to be
- 21 used with or in an electronic cigarette, electronic cigar, electronic
- 22 cigarillo, electronic pipe, or similar product or device. Vapor product
- 23 does not include an alternative nicotine product, cigarette, cigar, or
- 24 other tobacco product, or any product regulated as a drug or device by
- 25 the United States Food and Drug Administration under Chapter V of the
- 26 federal Food, Drug, and Cosmetic Act.
- 27 Sec. 3. Section 28-1419, Reissue Revised Statutes of Nebraska, is
- 28 amended to read:
- 29 28-1419 (1) Whoever shall sell, give, or furnish, in any way, any
- 30 tobacco in any form whatever, or any cigarettes, cigarette paper, vapor
- 31 products, or alternative nicotine products, to any minor under eighteen

- 1 years of age, is guilty of a Class III misdemeanor for each offense.
- 2 (2) Whoever shall sell, give, or furnish, in any way, any vapor
- 3 products or flavored liquids, to any individual under twenty-one years of
- 4 age, is guilty of a Class III misdemeanor for each offense.
- 5 Sec. 4. Section 28-1420, Reissue Revised Statutes of Nebraska, is
- 6 amended to read:
- 7 28-1420 It shall be unlawful for any person, partnership, limited
- 8 liability company, or corporation to sell, keep for sale, or give away in
- 9 course of trade, any cigars, tobacco, cigarettes, or cigarette material,
- 10 or vapor products to anyone without first obtaining a license as provided
- 11 in sections 28-1421 and 28-1422. It shall also be unlawful for any
- 12 wholesaler to sell or deliver any cigars, tobacco, cigarettes, or
- 13 cigarette material, or vapor products to any person, partnership, limited
- 14 liability company, or corporation who, at the time of such sale or
- delivery, is not the recipient of a valid <del>tobacco</del> license for the current
- 16 year to retail the same as provided in such sections. It shall also be
- 17 unlawful for any person, partnership, limited liability company, or
- 18 corporation to purchase or receive, for purposes of resale, any cigars,
- 19 tobacco, cigarettes, or cigarette material, or vapor products if such
- 20 person, partnership, limited liability company, or corporation is not the
- 21 recipient of a valid tobacco license to retail such tobacco products at
- 22 the time the same are purchased or received. Whoever shall be found
- 23 quilty of violating this section shall be quilty of a Class III
- 24 misdemeanor for each offense.
- 25 Sec. 5. Section 28-1421, Reissue Revised Statutes of Nebraska, is

- 27 28-1421 Licenses for the sale of cigars, tobacco, cigarettes, and
- 28 cigarette material, and vapor products to persons of sufficient age to
- 29 lawfully use such products over the age of eighteen years shall be issued
- 30 to individuals, partnerships, limited liability companies, and
- 31 corporations by the clerk or finance director of any city or village and

- 2 in section 28-1422. The sale of cigarettes or cigarette materials that
- 3 contain perfumes or drugs in any form is prohibited and is not licensed
- 4 by the provisions of this section. Only cigarettes and cigarette material
- 5 containing pure white paper and pure tobacco shall be licensed.

28-1423 The term for which such license shall run shall be from the 8 9 date of filing such application and paying such license fee to and 10 including December 31 of the calendar year in which application for such license is made, and the license fee for any person, partnership, limited 11 liability company, or corporation selling at retail shall be twenty-five 12 13 dollars in cities of the metropolitan class, fifteen dollars in cities of the primary and first classes, and ten dollars in cities of all other 14 classes, and in towns and villages, and in locations outside of the 15 limits of cities, towns, and villages. Any person, partnership, limited 16 17 liability company, or corporation selling annually in the aggregate more than one hundred fifty thousand cigars, packages of cigarettes, and 18 packages of tobacco, and packages of vapor products in any form, at 19 wholesale, shall pay a license fee of one hundred dollars, and if such 20 combined annual sales amount to less than one hundred fifty thousand 21 22 cigars, packages of cigarettes, and packages of tobacco, and packages of vapor products, the annual license fee shall be fifteen dollars. No 23 24 wholesaler's license shall be issued in any year on a less basis than one 25 hundred dollars per annum unless the applicant for the same shall file with such application a statement duly sworn to by himself or herself, or 26 if applicant is a partnership, by a member of the firm, or if a limited 27 28 liability company, by a member or manager of the company, or if a corporation, by an officer or manager thereof, that in the past such 29 wholesaler's combined sales of cigars, packages of cigarettes, and 30 packages of tobacco, and packages of vapor products in every form have 31

- 1 not exceeded in the aggregate one hundred fifty thousand annually, and
- 2 that such sales will not exceed such aggregate amount for the current
- 3 year for which the license is to issue. Any person swearing falsely in
- 4 such affidavit shall be guilty of perjury and upon conviction thereof
- 5 shall be punished as provided by section 28-915 and such wholesaler's
- 6 license shall be revoked until the full license fee of one hundred
- 7 dollars is paid. If application for license is made after July 1 of any
- 8 calendar year, the fee shall be one-half of the fee provided in this
- 9 section.
- 10 Sec. 7. Section 28-1424, Reissue Revised Statutes of Nebraska, is
- 11 amended to read:
- 12 28-1424 The license, provided for in sections 28-1421 and 28-1422
- 13 when issued, shall authorize the sale of cigars, tobacco, cigarettes, and
- 14 cigarette material, and vapor products by the licensee and employees, to
- 15 persons of sufficient age to lawfully use such products over the age of
- 16 eighteen years, at the place of business described in such license for
- 17 the term therein authorized, unless the same be forfeited as provided in
- 18 section 28-1425.
- 19 Sec. 8. Section 28-1425, Reissue Revised Statutes of Nebraska, is
- 20 amended to read:
- 21 28-1425 Any licensee who shall sell, give, or furnish in any way to
- 22 any person under the age of eighteen years, or who shall willingly allow
- 23 to be taken from his or her place of business by any person under the age
- 24 of eighteen years, any cigars, tobacco, cigarettes, cigarette material,
- 25 vapor products, <u>flavored liquids</u>, or alternative nicotine products to any
- 26 person who is not of sufficient age to lawfully use such products, or who
- 27 <u>shall willingly allow any cigars, tobacco, cigarettes, cigarette</u>
- 28 material, vapor products, flavored liquids, or alternative nicotine
- 29 products to be taken from his or her place of business by any person who
- 30 <u>is not of sufficient age to lawfully use such products,</u> is guilty of a
- 31 Class III misdemeanor. Any officer, director, or manager having charge or

- 1 control, either separately or jointly with others, of the business of any
- 2 corporation which violates sections 28-1418.01, 28-1420 to 28-1429, and
- 3 28-1429.03, if he or she has knowledge of such violation, shall be
- 4 subject to the penalties provided in this section. In addition to the
- 5 penalties provided in this section, such licensee shall be subject to the
- 6 additional penalty of a revocation and forfeiture of his, her, their, or
- 7 its license, at the discretion of the court before whom the complaint for
- 8 violation of such sections may be heard. If such license is revoked and
- 9 forfeited, all rights under such license shall at once cease and
- 10 terminate.

- 13 28-1427 (1) Any person under the age of eighteen years who shall
- 14 obtain cigars, tobacco, cigarettes, cigarette material, vapor products,

- 16 or she is of the age of eighteen years or over is guilty of a Class V
- 17 misdemeanor.
- 18 (2) Any person under the age of twenty-one years who shall obtain
- 19 vapor products or flavored liquids from a licensee by representing that
- 20 <u>he or she is of the age of twenty-one years or over is guilty of a Class</u>
- 21 <u>V misdemeanor</u>.
- 22 Sec. 10. Section 28-1429.01, Reissue Revised Statutes of Nebraska,
- 23 is amended to read:
- 24 28-1429.01 The Legislature finds that the incumbent health risks
- 25 associated with using cigarettes, other smoking tobacco products, vapor
- 26 <u>products</u>, <u>and alternative nicotine products</u> have been scientifically
- 27 proven. The Legislature further finds that the growing number of young
- 28 <u>people minors</u> who start <u>using these products</u> <del>smoking</del> is staggering and
- 29 even more abhorrent are the ages at which such use begins children begin
- 30 this deadly habit. The Legislature has established an age restrictions
- 31 restriction on the use of <u>such</u> tobacco products by minors. To ensure that

- 1 the use of <u>such</u> tobacco products among <u>young people</u> minors is discouraged
- 2 to the maximum extent possible, it is the intent of the Legislature to
- 3 ban the use of vending machines and similar devices to dispense such
- 4 tobacco products in facilities, buildings, or areas which are open to the
- 5 general public within Nebraska.
- 6 Sec. 11. Section 28-1429.02, Reissue Revised Statutes of Nebraska,
- 7 is amended to read:
- 8 28-1429.02 (1) Except as provided in subsection (2) of this section,
- 9 it shall be unlawful to dispense cigarettes, other tobacco products,
- 10 vapor products, or alternative nicotine products from a vending machine
- 11 or similar device. Any person violating this section is quilty of a Class
- 12 III misdemeanor. In addition, upon conviction for a second offense, the
- 13 court shall order a six-month suspension of the offender's license issued
- 14 under section 28-1421 to sell tobacco, if any, and, upon conviction for a
- 15 third or subsequent offense, the court shall order the permanent
- 16 revocation of the offender's license issued under section 28-1421 to sell
- 17 tobacco, if any.
- 18 (2) Cigarettes, other tobacco products, vapor products, or
- 19 alternative nicotine products may be dispensed from a vending machine or
- 20 similar device when such machine or device is located in an area, office,
- 21 business, plant, or factory which is not open to the general public or on
- 22 the licensed premises of any establishment having a license issued under
- 23 the Nebraska Liquor Control Act for the sale of alcoholic liquor for
- 24 consumption on the premises when such machine or device is located in the
- 25 same room in which the alcoholic liquor is dispensed.
- 26 (3) Nothing in this section shall be construed to restrict or
- 27 prohibit a governing body of a city or village from establishing and
- 28 enforcing ordinances at least as stringent as or more stringent than the
- 29 provisions of this section.
