# **LEGISLATIVE BILL 647**

Committee: Education

- A BILL FOR AN ACT relating to schools; to amend sections 79-528 and 79-1003, Revised Statutes Cumulative Supplement, 2018; to change
- 3 reporting requirements; to define and redefine terms; to include
- 4 virtual school students in the calculation of aid under the Tax
- 5 Equity and Educational Opportunities Support Act; to harmonize
- 6 provisions; and to repeal the original sections.
- 7 Be it enacted by the people of the State of Nebraska,

- 1 Section 1. Section 79-528, Revised Statutes Cumulative Supplement,
- 2 2018, is amended to read:
- 3 79-528 (1)(a) On or before July 20 in all school districts, the
- 4 superintendent shall file with the State Department of Education a report
- 5 showing the number of children from five through eighteen years of age
- 6 belonging to the school district according to the census taken as
- 7 provided in sections 79-524 and 79-578.
- 8 (b) The board of any district neglecting to take and report the
- 9 enumeration shall be liable to the school district for all school money
- 10 which such district may lose by such neglect.
- 11 (2) On or before June 30 the superintendent of each school district
- 12 shall file with the Commissioner of Education a report described as an
- 13 end-of-the-school-year annual statistical summary showing (a) the number
- 14 of children attending school during the year under five years of age, (b)
- 15 the length of time the school has been taught during the year by a
- 16 qualified teacher, (c) the length of time taught by each substitute
- 17 teacher, (d) the number of classes a student is required to enroll in for
- 18 full-time enrollment in the district at each grade level for the school
- 19 year, (e) the definition of a class used by the district for the purpose
- 20 of determining full-time and part-time enrollment at each grade level for
- 21 the school year, (f) the number of classes completed by each virtual
- 22 school student as defined in section 79-1003 for the school year, and (g)
- 23 <del>(d)</del> such other information as the Commissioner of Education directs.
- 24 (3) On or before November 1 the superintendent of each school
- 25 district shall submit to the Commissioner of Education a report described
- 26 as the annual financial report showing (i) the amount of money received
- 27 from all sources during the year and the amount of money expended by the
- 28 school district during the year, (ii) the amount of bonded indebtedness,
- 29 (iii) such other information as shall be necessary to fulfill the
- 30 requirements of the Tax Equity and Educational Opportunities Support Act
- 31 and section 79-1114, and (iv) such other information as the Commissioner

(4)(a) On or before October 15 of each year, the superintendent of 2 each school district shall file with the commissioner the fall school 3 district membership report, which report shall include the number of 4 5 children from birth through twenty years of age enrolled in the district on October 1 of a given school year. The report shall also include 6 enumerate (i) students by grade level, (ii) school district levies and 7 total assessed valuation for the current fiscal year, (iii) students 8 9 enrolled in the district as option students, (iv) resident students enrolled in another district as option students, (v) students enrolled in 10 the district as open enrollment students, (vi) and resident students 11 enrolled in another district as open enrollment students, (vii) the 12 13 number of classes a student is required to enroll in for full-time enrollment in the district at each grade level for such school year, 14 (viii) the definition of a class used by the district for the purpose of 15 16 determining full-time and part-time enrollment at each grade level for such school year, (ix) the number of classes in which each virtual school 17 student as defined in section 79-1003 is enrolled on October 1 of such 18 19 school year, and (x) and (iv) such other information as the Commissioner of Education directs. 20

(b) On or before October 15 of each year prior to 2017, each learning community coordinating council shall issue to the department a report which enumerates the learning community levies pursuant to subdivision (2)(b) of section 77-3442 and total assessed valuation for the current fiscal year.

(b) (c) When any school district fails to submit its fall membership report by November 1, the commissioner shall, after notice to the district and an opportunity to be heard, direct that any state aid granted pursuant to the Tax Equity and Educational Opportunities Support Act be withheld until such time as the report is received by the department. In addition, the commissioner shall direct the county

- 28 to the community eligibility provision, students who individually
- 29 qualified for free lunches or free milk pursuant to the federal Richard
- 30 B. Russell National School Lunch Act, 42 U.S.C. 1751 et seq., and the
- 31 federal Child Nutrition Act of 1966, 42 U.S.C. 1771 et seq., as such acts

- and sections existed on January 1, 2015, and rules and regulations 1 2 adopted thereunder, plus (b) for schools that provided free meals to all students pursuant to the community eligibility provision, (i) for school 3 fiscal year 2016-17, the product of the students who attended such school 4 multiplied by the identified student percentage calculated pursuant to 5 such federal provision or (ii) for school fiscal year 2017-18 and each 6 school fiscal year thereafter, the greater of the number of students in 7 such school who individually qualified for free lunch or free milk using 8 9 the most recent school fiscal year for which the school did not provide free meals to all students pursuant to the community eligibility 10 provision or one hundred ten percent of the product of the students who 11 qualified for free meals at such school pursuant to the community 12 13 eligibility provision multiplied by the identified student percentage calculated pursuant to such federal provision, except that the free lunch 14 and free milk students calculated for any school pursuant to subdivision 15 16 (18)(b)(ii) of this section shall not exceed one hundred percent of the students qualified for free meals at such school pursuant to the 17 community eligibility provision; 18
- 19 (19) Free lunch and free milk student means, for school fiscal years 20 prior to school fiscal year 2016-17, a student who qualified for free 21 lunches or free milk from the most recent data available on November 1 of 22 the school fiscal year immediately preceding the school fiscal year in 23 which aid is to be paid;
- (20) Full-day kindergarten means kindergarten offered by a district for at least one thousand thirty-two instructional hours;
- (21) General fund budget of expenditures means the total budget of disbursements and transfers for general fund purposes as certified in the budget statement adopted pursuant to the Nebraska Budget Act, except that for purposes of the limitation imposed in section 79-1023, the general fund budget of expenditures does not include any special grant funds, exclusive of local matching funds, received by a district;

1 (22) General fund expenditures means all expenditures from the 2 general fund;

3 (23) General fund operating expenditures means for state aid 4 calculated for school fiscal years 2012-13 and each school fiscal year 5 thereafter, as reported on the annual financial report for the second school fiscal year immediately preceding the school fiscal year in which 6 aid is to be paid, the total general fund expenditures minus (a) the 7 amount of all receipts to the general fund, to the extent that such 8 9 receipts are not included in local system formula resources, from early childhood education tuition, summer school tuition, educational entities 10 as defined in section 79-1201.01 for providing distance education courses 11 through the Educational Service Unit Coordinating Council to such 12 13 educational entities, private foundations, individuals, associations, 14 charitable organizations, the textbook loan program authorized by section 79-734, federal impact aid, and levy override elections pursuant to 15 section 77-3444, (b) the amount of expenditures for categorical funds, 16 tuition paid, transportation fees paid to other districts, adult 17 education, community services, redemption of the principal portion of 18 general fund debt service, retirement incentive plans authorized by 19 section 79-855, and staff development assistance authorized by section 20 79-856, (c) the amount of any transfers from the general fund to any bond 21 fund and transfers from other funds into the general fund, (d) any legal 22 23 expenses in excess of fifteen-hundredths of one percent of the formula 24 need for the school fiscal year in which the expenses occurred, (e)(i) 25 for state aid calculated for school fiscal years prior to school fiscal year 2018-19, expenditures to pay for sums agreed to be paid by a school 26 27 district to certificated employees in exchange for a voluntary termination occurring prior to July 1, 2009, occurring on or after the 28 last day of the 2010-11 school year and prior to the first day of the 29 2013-14 school year, or, to the extent that a district has demonstrated 30 to the State Board of Education pursuant to section 79-1028.01 that the 31

- 12 (27) Local system means a unified system or a school district;
- 13 (28) Low-income child means (a) for school fiscal years prior to 2016-17, a child under nineteen years of age living in a household having 14 an annual adjusted gross income for the second calendar year preceding 15 16 the beginning of the school fiscal year for which aid is being calculated equal to or less than the maximum household income that would allow a 17 student from a family of four people to be a free lunch and free milk 18 student during the school fiscal year immediately preceding the school 19 fiscal year for which aid is being calculated and (b) for school fiscal 20 year 2016-17 and each school fiscal year thereafter, a child under 21 nineteen years of age living in a household having an annual adjusted 22 23 gross income for the second calendar year preceding the beginning of the 24 school fiscal year for which aid is being calculated equal to or less than the maximum household income pursuant to sections 9(b)(1) and 17(c)25 (4) of the Richard B. Russell National School Lunch Act, 42 U.S.C. 26 1758(b)(1) and 42 U.S.C. 1766(c)(4), respectively, and sections 3(a)(6)27 28 and 4(e)(1)(A) of the Child Nutrition Act of 1966, 42 U.S.C. 1772(a)(6) and 42 U.S.C. 1773(e)(1)(A), respectively, as such acts and sections 29 existed on January 1, 2015, for a household of that size that would have 30 allowed the child to meet the income qualifications for free meals during 31

- 3 (29) Low-income students means the number of low-income children
- 4 within the district multiplied by the ratio of the formula students in
- 5 the district divided by the total children under nineteen years of age
- 6 residing in the district as derived from income tax information;
- 7 (30) Most recently available complete data year means the most
- 8 recent single school fiscal year for which the annual financial report,
- 9 fall school district membership report, annual statistical summary,
- 10 Nebraska income tax liability by school district for the calendar year in
- 11 which the majority of the school fiscal year falls, and adjusted
- 12 valuation data are available;
- 13 (31) Poverty students means (a) for school fiscal years prior to
- 14 2016-17, the number of low-income students or the number of students who
- 15 are free lunch and free milk students in a district plus the difference
- of the number of low-income students or the number of students who are
- 17 free lunch and free milk students in a district, whichever is greater,
- 18 minus the average number of poverty students for such district, prior to
- 19 such addition, for the three immediately preceding school fiscal years if
- 20 such difference is greater than zero and (b) for school fiscal year
- 21 2016-17 and each school fiscal year thereafter, the unadjusted poverty
- 22 students plus the difference of such unadjusted poverty students minus
- 23 the average number of poverty students for such district, prior to such
- 24 addition, for the three immediately preceding school fiscal years if such
- 25 difference is greater than zero;
- 26 (32) Proportionate share of students enrolled in a public school
- 27 <u>instructional program on less than a full-time basis</u> means, for both
- 28 virtual school students and students who are not virtual school students
- 29 who are enrolled in a public school instructional program on less than a
- 30 full-time basis, (a) for the purposes of fall membership, the number of
- 31 classes for which such students are enrolled in a public school

- 1 section 79-1103 for such school year and the two preceding school years,
- 2 including any such students in portions of any of such programs receiving
- 3 an expansion grant;
- 4 (35) (34) Regular route transportation means the transportation of
- 5 students on regularly scheduled daily routes to and from the attendance
- 6 center;
- 7 (36) (35) Reorganized district means any district involved in a
- 8 consolidation and currently educating students following consolidation;
- 9 (37) (36) School year or school fiscal year means the fiscal year of
- 10 a school district as defined in section 79-1091;
