

# LEGISLATIVE BILL 570A

Approved by the Governor May 17, 2019

Introduced by Walz, 15.

A BILL FOR AN ACT relating to appropriations; to amend Laws 2018, LB944, section 15; to appropriate funds to aid in carrying out the provisions of Legislative Bill 570, One Hundred Sixth Legislature, First Session, 2019; to reduce an appropriation as prescribed; to state intent; to repeal the original section; and to declare an emergency.

Be it enacted by the people of the State of Nebraska,

Section 1. Laws 2018, LB944, section 15, is amended to read:

There is included in the appropriation to this program for FY2017-18 \$75,000 Cash Funds and for FY2018-19 \$75,000 Cash Funds from the Nebraska Health Care Cash Fund for the purpose of ongoing health-related research and public policy development by the Health and Human Services Committee of the Legislature. Such funds may be used for, but shall not be limited to, hiring temporary legal research assistance, consulting and research contracts, reimbursement for necessary and appropriate expenses incurred in connection with such research and policy development, and actual and necessary travel reimbursement for task forces and committees established to conduct health policy work.

The unexpended General Fund appropriation balance existing on June 30, 2017, is hereby reappropriated.

The unexpended and unobligated balance in the Nebraska Health Care Cash Fund appropriation shall be reduced by \$105,740 on or before June 15, 2019.

Sec. 2. There is hereby appropriated (1) \$18,600 from the Nebraska Health Care Cash Fund for FY2018-19, (2) \$43,570 from the Nebraska Health Care Cash Fund for FY2019-20, and (3) \$43,570 from the Nebraska Health Care Cash Fund for FY2020-21 to the Department of Health and Human Services, for Program 33, to aid in carrying out the provisions of Legislative Bill 570, One Hundred Sixth Legislature, First Session, 2019.

No expenditures for permanent and temporary salaries and per diems for state employees shall be made from funds appropriated in this section.

Sec. 3. There is hereby appropriated (1) \$18,600 from federal funds for FY2018-19, (2) \$43,570 from federal funds for FY2019-20, and (3) \$43,570 from federal funds for FY2020-21 to the Department of Health and Human Services, for Program 33, to aid in carrying out the provisions of Legislative Bill 570, One Hundred Sixth Legislature, First Session, 2019.

No expenditures for permanent and temporary salaries and per diems for state employees shall be made from funds appropriated in this section.

Sec. 4. It is the intent of the Legislature to appropriate \$36,459 from the Nebraska Health Care Cash Fund for FY2021-22 to the Department of Health and Human Services, for Program 33.

Sec. 5. Original Laws 2018, LB944, section 15, is repealed.

Sec. 6. Since an emergency exists, this act takes effect when passed and approved according to law.
