- 1 1. Strike the original sections and all amendments thereto and
- 2 insert the following new sections:
- 3 Section 1. Sections 1 to 6 of this act shall be known and may be
- 4 cited as the 24/7 Sobriety Program Act.
- 5 Sec. 2. (1) The Legislature finds and declares that there are many
- 6 <u>different approaches to assist individuals who struggle with substance</u>
- 7 abuse. Alternatives to incarceration should be considered in order to
- 8 reduce the cost to the taxpayers, successfully rehabilitate offenders,
- 9 ensure public safety, and minimize risk to society. Ignition interlock
- 10 devices, which are required to be installed for those who are charged
- 11 with or have been convicted of certain offenses, while effective, may be
- 12 a financial burden to those who cannot afford the costs of installation
- 13 or maintenance of such devices. In this state, ignition interlock devices
- 14 have been proven to be an effective means of preventing drivers from
- 15 operating motor vehicles while under the influence of alcohol. Other
- 16 states have implemented 24/7 sobriety programs. States that implement
- 17 24/7 sobriety programs have seen success with such programs in that
- 18 participants have higher rates of maintaining sobriety, have lower rates
- 19 of recidivism, are more likely to become productive members of society,
- 20 and are less likely to be a continued public risk. Therefore, it is in
- 21 <u>the best interests of the State of Nebraska to establish 24/7 sobriety</u>
- 22 programs.
- 23 (2) A 24/7 sobriety program shall coordinate efforts among various
- 24 state and local governmental agencies for finding and implementing
- 25 alternatives to incarceration for offenses that involve operating a motor
- 26 vehicle under the influence of alcohol or other drugs.
- Sec. 3. <u>For purposes of the 24/7 Sobriety Program Act:</u>

1 (1) 24/7 sobriety program means a program that, as a condition of

- 2 bail, requires an individual who was arrested to:
- 3 (a) Totally abstain from alcohol and drugs for a specified period of
- 4 time;
- 5 (b) Be subject to at least twice daily testing for alcohol according
- 6 to best practice standards; and
- 7 (c) Be subject to drug testing if indicated by best practices;
- 8 (2) Department means the Department of Motor Vehicles;
- 9 (3) Director means the Director of Motor Vehicles; and
- 10 (4) Testing means a method to determine the presence of alcohol or
- 11 <u>drugs.</u>
- 12 Sec. 4. (1) Each county, through its county sheriff, may
- 13 participate in a 24/7 sobriety program. If a sheriff is unwilling or
- 14 <u>unable to participate in a 24/7 sobriety program, the sheriff may</u>
- 15 <u>designate an entity willing to provide the service.</u>
- 16 (2) A 24/7 sobriety program shall meet at least the following
- 17 <u>minimum program requirements:</u>
- 18 (a) Testing shall occur either twice a day or every day at a testing
- 19 location or locations established by the county sheriff or a designated
- 20 entity or continuously with a continuous alcohol monitoring device or
- 21 <u>similar technology;</u>
- 22 (b) Participants shall enter into a participation agreement with the
- 23 <u>sheriff or designated entity; and</u>
- 24 (c) Participants shall not consume alcohol or any drug not
- 25 prescribed by a physician.
- 26 (3) If a test reveals a violation of the 24/7 sobriety program,
- 27 sanctions imposed shall be immediate and certain and in accordance with
- 28 best practices, as set forth in the participation agreement. A sixth
- 29 <u>sanction against a participant charged with an alcohol-related offense</u>
- 30 <u>shall be removal from the 24/7 sobriety program and the participant shall</u>
- 31 be ineligible for further participation in the program for that case.

- 1 Sanctions for new drug use may be more severe and shall be outlined in
- 2 <u>the participation agreement.</u>
- 3 (4) The sheriff or designated entity shall establish a reasonable
- 4 fee to cover the setup and operation of a 24/7 sobriety program for all
- 5 participants. Reasonable program and testing fees may be charged. Testing
- 6 costs may vary by participant depending on the technology employed.
- 7 Testing costs may be higher if the participant is involved in the program
- 8 <u>due to a non-alcohol, drug-related offense. All fees and costs charged</u>
- 9 pursuant to this subsection shall be set forth in the participation
- 10 <u>agreement</u>. Such costs and fees may be waived by the court if the
