Dear Mr. O'Donnell,

According to Nebraska State Statues, Chapter 82 Section 333, the Nebraska Arts Council shall provide the Clerk of the Legislature and Director of Administrative Services annually the Nebraska Arts and Humanities Cash Fund report. Please review the following information for the period of July 1, 2020 to June 30, 2021.

- 1) Enclosed is an overview of the Nebraska Cultural Endowment, which raises the matching funds for the Cultural Preservation Endowment Fund. The Nebraska Arts and Humanities Cash Fund (26920) consists of all funds credited from the Cultural Preservation Endowment Fund.
- 2) The funds credited to the Nebraska Arts and Humanities Cash Fund (26920) totaled \$1,153,268.

3) The required match was submitted to the Budget Office for the following transfer of funds from the General Fund to the Cultural Preservation Endowment Fund.

Creative Solutions to Sustain Connection

incoln Community Playhouse has long been known for their transformative programming through The Penguin Project.

The Penguin Project creates a space where participants with special needs, ages 10 to 22, can engage in the performing arts. Participants are partnered with peer mentors and work together to learn lines, staging and other aspects of performing a production.

Jacob, a seven-season participant, blossomed through The Penguin Project. Jacob's mom, Vicki, said, "When Jacob got his costume on it was like watching a light switch go on."

For those that thrive on routine, the pandemic's effects were particularly challenging. For participants, the lack of rehearsals, performances, and time with their peer mentors, among other changes, was heartbreaking. The directors of The Penguin Project put together virtual gatherings for the Penguins to help them stay connected. Through these events, the Penguins sing and dance together and share their individual successes and challenges. These connections have been powerful in overcoming the isolation and disrupted routines of these times.

General performances at the Playhouse also came to a halt, which significantly impacted the organization's revenues and ability to sustain programs like The Penguin Project. Federal relief and funding provided by the Nebraska Cultural Endowment and Nebraska Arts

Council kept everyone employed and programs active. "It is a great feeling knowing that NCE and NAC had our backs during the pandemic," said Morrie Enders. Executive Director.

The Playhouse got creative in finding solutions to keep patrons safely engaged. By presenting "Parking Lot Plays," the Playhouse was able to provide some sense of normalcy to their patrons, and attendees were grateful to attend performances again. Nineteen sold out performances were held, ranging from melodramas to a Mamma Mia Reunion.

The performances were featured on Good Morning America in a nationwide segment. Innovation made a difficult situation more tolerable. "I believe that the theater is going to be part of the emotional recovery from this pandemic," said Enders. ■



A Legacy for Family & Community

acquelyn E. "Jackie" Rosenlof was a champion for many causes during her lifetime. She also cared deeply for her children and grandchildren, and she left a legacy of values by sharing this love of community with them.

Jackie's four children and 14 grandchildren would often visit her in Kearney. They would go to the Archway, Kearney Area Children's Museum, and Museum of Nebraska Art, and they would attend performances at the Crane River Theater and Kearney Community Theatre.

"Our mother shared her love of the arts with friends, family, and anyone who was interested," said Lori Drake, Jackie's daughter, on behalf of the Rosenlof Family.

Through gubernatorial appointments to the Nebraska Library Commission and Nebraska Arts Council in the 1980's and 90's, Jackie saw how the arts and humanities enriched not only individual lives but also served to strengthen the fabric of community. "She understood that



nding 2019 on a high note, the Kearney Community Theatre was eager to kick off its 2020 season. After eager to kick on its 2022 selling out shows and engaging several new volunteers and actors, the world was struck by the Coronavirus pandemic. Like many venues, they shut their doors to ensure the safety of the more than 1,000 patrons coming from miles away.

After some time, the Theatre presented a few performances by implementing rigorous safety measures like capacity reduction, sanitization, and personal protection equipment for cast and patrons.

Rehearsals were conducted remotely and in person, but cast members were challenged both emotionally and mentally to prepare for performances that may be cancelled. Even with all the safety measures, the Theatre's revenues

took a huge hit. "Without the grant money from NCE and NAC, we would not be where we are." said Judy Rozema, Executive Director. "If not for that, we would have had to close our doors."

Out of every challenge comes an opportunity. While the stage was dark, staff had the time to organize the prop room, clear out old costumes. and renovate the bathrooms. Thanks to relief funding and this time for reflection, the Theatre is looking towards the future with hope and increased preparedness.

The show will go on for the Kearney Community Theatre. Thanks to your generous contributions, the NCE sustains many vital cultural organizations throughout the state. 

n 2020, the Nebraska Cultural
Endowment was proud to play an
unprecedented role in providing relief
for Nebraska's arts and humanities
organizations statewide, many of whom were
at risk of closing due to crushing revenue
losses due to the ongoing pandemic. Thanks
to consistent donor support and effective fund
stewardship, the NCE Board of Directors voted
to release a "special distribution" of \$300,000
to support Nebraska's cultural infrastructure.

The Nebraska Arts Council and Humanities
Nebraska deployed these funds to sustain
organizations vital to Nebraska's cultural
economy and quality of life, allowing many of
our partners to remain afloat and to invest in
delivering programs in new, innovative ways.

Legislative Update

egislative Alert: Under new legislation included in the Nebraska State Budget, the State has doubled its annual commitment to the NCE's public matching fund, the Cultural Preservation Endowment Fund (CPEF).

This arrangement allows the NCE to facilitate an increase in the CPEF's value by \$10 million by raising \$10 million in matching funds through private contributions. Success will yield combined cultural endowment funds of over \$40 million and annual distributions of over \$2 million.

The NCE is grateful for this opportunity to increase its annual impact on Nebraska's arts and humanities organizations through permanent support of the Nebraska Arts Council and Humanities Nebraska.



Inclusion & Accessibility — Changing Lives Through Art

nclusivity and Accessibility have taken on a renewed importance in recent months. At the heart of the Carnegie Arts Center in Alliance, Nebraska is the drive to make art meaningful — regardless of a family's income, access to transportation, or any physical, mental, or developmental disabilities.

Modeling this value, the Carnegie cultivated its educational outreach by partnering with groups that serve seniors, children, and families to offer accessible art classes.

"Our educational outreach absolutely would not be possible without generous grant support," said Kyren Conley, Executive Director. With 70% of those they serve coming from lowincome households, grant support through funders like the Nebraska Arts Council and the



NCE is vital to their success. "Without grant funding there would be no way that we could afford to offer free or reduced cost classes," said Conley. "We would be neglecting such large, vibrant populations."

These programs create meaningful and visible impact on the lives they touch. One nursing home resident began experiencing positive changes in communication and engagement levels through arts interaction and creative projects. For some, the arts can become an opportunity to connect with their community in a new way. It can also be a way to take back independence that may have been diminished by age or circumstance.
