Mr. O'Donnell,

Nebraska Statute 83-4,134.01 requires Nebraska's juvenile facilities to report quarterly to the Legislature and the Office of the Inspector General within two weeks after the end of each quarter, information regarding the use of room confinement in Nebraska's juvenile facilities.

On October 1, 2020, the youth placed at the Hastings Chemical Dependency Center were relocated to the Whitehall Psychiatric Treatment Facility campus in Lincoln, Nebraska. The campus was combined to house both a youth chemical dependency treatment program and a treatment program for youth who sexually harm. The Hastings Regional Center, which was the location of the Hastings Chemical Dependency Center, is currently not in use.

Respectfully, the Whitehall Psychiatric Treatment Facility submits the following information for usage of room confinement for the second quarter of fiscal year 2020/2021.

• October 1, 2020 to December 31, 2020: No room confinement was used.

While the child care license in which the Whitehall Psychiatric Treatment Facility is authorized to provide services allows for the use of room confinement, the facility has elected to not use this as an option for behavioral management for youth and as such does not allow this practice in our policies or procedures. The facility staff have elected and will continue to use behavioral management techniques with youth that aid in their de-escalation without the use of room confinement but still provide the safest environment for our youth and staff.

Nebraska Statute 83-4,134.01 requires Nebraska's juvenile facilities to report quarterly to the Legislature within two weeks after the end of each quarter, information regarding the use of room confinement in Nebraska's juvenile facilities.

Attached, please find letters certifying that the Whitehall Psychiatric Residential Treatment Facility and the Youth Rehabilitation and Treatment Center at Geneva did not utilize room confinement for the second quarter of fiscal year 2020/2021.

Also attached is the room confinement usage data for both the Youth Rehabilitation and Treatment Center at Kearney and the DHHS Office of Juvenile Services (DHHS OJS) Lincoln facility for the second quarter of fiscal year 2020/2021. Both facilities followed Center for Disease Control (CDC) and local Public Health Department recommendations on the use of medical quarantine for youth testing positive or exposed to COVID-19.

The Youth Rehabilitation and Treatment Center system continues to use room confinement as a behavioral management tool for the high risk youth in our care. Efforts are continually being made to ensure that youth are only in confinement for the shortest amount of time possible to ensure their safety and the safety of the other youth and staff around them.
