- LB 1173e (*Health and Human Services Committee*) Create a work group and strategic leadership group for child welfare system reform, provide duties for the Department of Health and Human Services, require reports of child abuse or neglect, and change and eliminate provisions regarding lead agencies and a pilot project for child welfare system reform
