Summary of purpose and/or changes:

LB 239 would add offenses to the Nebraska Rules of the Road relating to using handheld wireless devices while operating a motor vehicle. Current law allows drivers to engage in handheld mobile phone calls while operating a motor vehicle, but prohibits the operator from reading a written communication, manually typing a written communication, or sending a written

communication while operating a motor vehicle which is in motion.

LB239 would prohibit an operator from engaging in a handheld mobile telephone call while operating a motor vehicle, and from accessing content stored on a handheld wireless communication device such as video content, audio content, images, games, or other applications. The bill also specifies that these rules would apply while a vehicle is in motion or is a part of traffic. The bill would add exceptions for:

- --solely voice-activated or hands-free calls or electronic messages;
- --viewing or operating GPS or navigation systems so long as the operator does not type while the vehicle is in motion or as a part of traffic, and the operator does not have to hold the device;
- --listening to audio-based content that does not require the operator to scroll, type, or hold the wireless communication device;
- --obtaining emergency assistance to report a traffic accident, medical emergency, serious traffic hazard, to prevent a criminal act, or in any other emergency situation.

Violation of this section would be treated as a secondary action when the driver is charged or cited for a violation of another traffic law or other offense. Generally, violators can be fined and will lose three points for violations relating to the impermissible use of a handheld wireless device.

Section-by-Section Summary

Section 1 would add language to section 60-6,179.01 to:

- --add engaging in a mobile phone telephone call and accessing content stored on a handheld wireless communication device while operating a motor vehicle to the list of offenses;
- --specify that it is an offense to take part in these activities not only while the vehicle is in motion, but while it is a part of traffic:
- --make exceptions for certain GPS/navigation system devices and certain hands-free uses of a handheld wireless device;
- --make exceptions for reporting traffic accidents, medical emergencies, serious traffic hazards, to prevent or stop a criminal act, or in any other emergency situation.

Section 2 would repeal the original section.
