## Summary of purpose and/or changes:

LB 540 makes numerous wording changes to statute sections referencing disability. The bill replaces phrases like handicap and listing of disabilities with more modern phrasing. The measure also replaces definitions of disability with references to the federal definition (42 USC 12102).
