Explanation of Estimate:

LB 273, as amended by AM1003, eases the movement of youth from one YRTC to another for appropriate treatment. The amendment will allow for an emergency change of placement to another YRTC. This will allow youth to be transferred more quickly (within 24 hours, excluding nonjudicial days) and the motion for the move may be held telephonically or via video.

The amendment outlines what information shall be in the motion for immediate change of placement and requires that the department make a reasonable attempt to provide notice of the motion to the juveniles's parent or guardian as well as provide any exhibits it intends to offer. The juvenile will have the opportunity before the hearing to consult with the juvenile's counsel.

This amendment will have no fiscal impact to the Department of Health and Human Services
