LB331 aims to prohibit the contracting of private entities for criminal enforcement of offenses against animals. Currently, the Humane Society can issue citations for criminal charges pertaining to crimes against animals. According to the bill's sponsor, the adoption of LB331 does not preclude the involvement Humane Society; it specifies that if criminal charges are to be filed, the police department has to be physically on site to issue the citation. There may be financial impact to local cities and counties, as noted by their fiscal note responses, but no direct fiscal impact to the state is expected.

This City of Omaha increased their projected fiscal impact to \$2,220,000 and provided more detail regarding the nature of the city's increased expenditures (see attached). The Fiscal Office disagrees that the bill, as written, would require the additional officers and equipment as listed by the City of Omaha.
