This bill would change provisions relating to credit against jail terms.

In 2021, the Supreme Court estimated a minimal fiscal impact.

This bill has the potential to reduce time spent in jail because it increases the credit received against a jail term. If the impact of this bill is to decrease the number of people serving time in county jails by more than current law, this could result in a savings to counties.

In 2021, Lancaster County Department of Corrections stated that this bill may reduce the average length of stay in jail, but they cannot quantify the reduction.

The Lancaster County Department of Corrections cannot accurately determine the fiscal impact of this bill. It is our opinion that this bill will likely reduce the average length of stay. However, a majority of individuals serving sentences and thus eligible for credit are also in custody on pre-trial cases. This makes it impossible for us to quantify the length of stay reduction.
